Amendment No. 1 to Personal Services Agreement No. C20230417 with North County Public Defense, PLLC to provide indigent defense representation to defendants referred by the Office of Assigned Counsel, Superior Court, Juvenile Court and District Court who have been deemed conflict of interest cases for the Skagit County Public Defender's Office. This Amendment includes new language in Exhibit "B" regarding registration and reimbursement for the Skagit County Odyssey Portal through the Skagit County Clerk's Office. Compensation remains the same and shall not exceed \$206,250. The term remains the same and shall continue until December 31, 2024.
