- 9. Resolution awarding the bid for the Purchase of Large Woody Debris (with rootwads attached) Project #RD76B-1,2,3 to Cherry Valley Logging in the amount of \$53,312.
- 10. Vendor Services Agreement with San Juan Marine Freight & Services, Inc. to haul heavy equipment to Sinclair Island for road operations crew to perform necessary road maintenance. Compensation is based on a rate schedule and shall not exceed \$3,000. The Agreement shall commence on the date of execution and continue for one year.
- 11. Vendor Services Agreement with Van's Equipment Co. to provide services/products that consist of equipment rental for various projects as needed. Compensation is based on a rate schedule and shall not exceed \$50,000. The Agreement is ratified to commence on February 1, 2024 and continue for one year.
- 12. Vendor Services Agreement with Thermo Fluids, Inc. for recycling of used motor oil, used oil filter, and used antifreeze from various Skagit County locations. Compensation is based on a rate schedule and shall not exceed \$39,000. The Agreement is ratified to commence on March 23, 2024 and continue for two (2) years with the option of one successive period of two (2) years on similar terms and conditions.
- 13. Vendor Services Agreement with Unitec Corporation to provide scale calibration, maintenance, and repair as it relates to the Skagit County Transfer and Recycling Station located at 14104 Ovenell Road in Mount Vernon, and the Sauk Transfer Station located at 50796 State Route 20 in Concrete. Compensation is based on a rate schedule and shall not exceed \$39,000. The Agreement shall commence on May 7, 2024 and continue for two (2) years with the option of one successive period of two (2) years on similar terms and conditions.

# d) SHERIFF:

14. Interlocal Agreement with San Juan County to house inmates in the Skagit County Community Justice Center until resolution of proceedings in San Juan Courts involving inmate or until such time as San Juan arranges transfer of San Juan Inmate to another correctional facility as lawfully discharged from custody pursuant to the law, the terms of a judicial Order of Commitment, and/or returned to the custody of San Juan/or other authority as directed by San Juan. Skagit County will bill San Juan County a booking fee of \$175 per inmate and daily maintenance fees. The daily maintenance fee shall be calculated based on the housing assignment (general population fee of \$190 and medical/mental health/specialty fee of \$250). The Agreement shall commence on July 1, 2024 and continue until December 31, 2027.
