Amendment No. 1 to Personal Services Agreement No. C20170113 with Octavio Choi, MD, PhD, to provide expert witness services to the Skagit County Prosecutor's office in the matter of the State of Washington v. Jason Becktel, Skagit County Superior Court Cause No. 15-1-00003-8, including but not limited to records review, pre-trial interviews, and testimony at trial. This Amendment modifies Exhibit B, to address only pre-trial work and reduces compensation by \$3,000. Total Compensation shall not exceed \$9,500. The term remains the same and shall continue until December 31, 2017. All other terms and conditions of the original Agreement shall remain in effect.
