- 12. Amendment No. 1 to Contract No. 243018-NUTR, Skagit County Contract No. C20240033, with Northwest Regional Council to provide meals and nutritional support through Congregate and Home Delivered Meals. This Amendment increases compensation to Skagit County from \$436,621 to an amount not to exceed \$456,322 and extends the term of the Agreement to continue until September 30, 2024. All other terms and conditions of the original Agreement shall remain in effect.
- 13. Amendment No. 1 to Professional Services Contract No. K7237, Skagit County Contract No. C20230533 with Washington State Health Care Authority to provide Substance Use Disorder short-term housing subsidies for Recovery Support Services using opioid abatement funds, for people with substance use disorders who are homeless or at risk of being homeless. This Amendment increases compensation from \$150,000 to an amount

- not to exceed \$300,000 and extends the term of the Agreement from June 30, 2024 to continue until June 30, 2025. All other terms and conditions of the original Agreement shall remain in effect.

Resolution to issue a Request for Qualifications (RFQ) for Professional Engineering and Environmental Services for three (3) Skagit County Fish Passage Improvements Projects: Bulson Road Bulson Creek (CR142), Project #ES80750-3; Starbird Road Unnamed Creek (CR80), Project #ES82000-4; and Cascade Ridge Drive Carpenter Creek (CR26) Project #ES82020-1. Interlocal Cooperative Agreement with Skagit Conservation District to authorize Skagit County to work with the District on a reimbursable basis for their assistance in meeting Title III funding priorities through the implementation of a county-wide Community Wildfire Protection Plan, and Firewise Communities/USA Program. Compensation shall not exceed \$36,358.38. The Agreement shall commence on June 16, 2024 and continue until June 1, 2025.
- 18. Vendor Services Agreement with Cummins, Inc. to provide engine control components incorporated into the ferry main engines and related materials and technical support to inspect and repair the engines for the Guemes Island Ferry, M/V Guemes, as authorized by (and pursuant to the terms of) a sole source resolution (Skagit County Resolution No. R20160153), dated May 31, 2016. Compensation shall not exceed \$150,000. The Agreement shall commence on May 22, 2024 and continue until May 22, 2026.
- 19. Services & Funding Agreement No. 4600015609 with Puget Sound Energy, Inc. (PSE) for the Lorenzan Creek Final Design. Compensation to Skagit County shall not exceed \$190,150. The Agreement is ratified to commence on May 9, 2024 and shall continue until December 31, 2027.
- 20. Amendment No. 3 to Vendor Services Agreement No. C20200404 with Reisner Distributor Inc. for the provision of Card Lock Fueling Services for county vehicles and other equipment. This Amendment reflects the Contractor's name change from Reisner Distributor Inc. to Nel/Son Distributing, Inc., dba NELSON-REISNER, increases compensation from \$4,050,000 to an amount not to exceed \$4,850,000 and extends the term of the Agreement to continue until August 24, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 21. Amendment No. 1 to Vendor Services Agreement No. C20230263 with Northwest Center Services dba Lithtex NW to print ferry tickets for the Skagit County ferry system. This Amendment extends the term of the Agreement from May 26, 2024 to May 26, 2025. Compensation remains the same and shall not exceed \$9,999. All other terms and conditions of the original Agreement shall remain in effect.
- 22. Amendment No. 2 to Local Agency A&E Professional Services Agreement No. C20220365 with Exceltech Engineering, Inc. for the design of eleven (11) Skagit County Fish Passage Improvement Projects. This Amendment amends Phase 2 Scope of Work, updates the rates, and increases compensation from \$1,173,345.93 to an amount not to exceed \$1,937,501.88. The completion date remains the same and shall continue until December 31, 2026. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 23. Amendment No. 1 to Vendor Services Agreement No. C20240141 with McAsphalt Industries for the procurement of road maintenance materials. This Amendment updates Exhibit "A" to include pages 1 through 3 which were inadvertently omitted (although such pages 1 through 3 were included in the original bid packet). Compensation remains the same and shall not exceed \$1,750,000. The term remains the same and shall continue until March 31, 2025. All other terms and conditions of the original Agreement shall remain in effect.
- 24. Amendment No. 2 to Vendor Serivces Agreement No. C20210243 with United Site Services of Nevada, Inc. to furnish and maintain portable toilet units at Guemes Ferry Dock, Ovenell Transfer Station, Sauk Transfer Station, Bonnar's Trading Post, Clear Lake Transfer Station, Bayview Edison Road/W. Edison Lane Intersection, and four county-owned units in the Burlington Yard. This Amendment increases compensation from \$48,000 to an amount not to exceed \$72,000 and extends the term from May 24, 2024 to May 24, 2025. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

- 25. Amendment No. 2 to Personal Services Agreement No. C20210486 with Cowling & Company LLC dba Widener & Associates for Environmental Permitting Services as needed, on a task order basis on non-federally funded capital projects. This Amendment updates the compensation rates. Total compensation remains the same and shall not exceed \$200,000. The term remains the same and shall continue until October 18, 2024. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 26. Amendment No. 1 to Interlocal Cooperative Agreement No. C20200613 with the City of Sedro-Woolley and Skagit County to allow each party to provide mutual assistance on minor projects and work and services on a reimbursable basis. This Amendment increases compensation from \$124,000 to an amount not to exceed \$189,000 and extends the term from June 30, 2024 to June 30, 2025. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 3. Amendment No. 3 to Personal Services Agreement No. C20230345 with Community Action of Skagit County for the provision of Tenant Based Rental Assistance (TBRA) with Federal HOME Funding through the Skagit HOME Consortium. This Amendment increases compensation from \$171,062.82 to an amount not to exceed \$190,402.78. The term remains the same and shall continue until June 30, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
