5. Memorandum of Agreement between Skagit County and the Skagit County Sheriff Patrol Guild to implement the wage results of the compensation study completed by Skagit County.

d) <u>INFORMATION</u> SERVICES:

6. Amendment No. 1 to Master License Agreement No. C20210213 with VertiGIS North America LTD. to maintain functionality with the GeoCortex mapping software used by Skagit County Geographic Information Service Department. This Amendment includes the CycloMedia interface and professional services to implement the module. Compensation for 2023 will be \$5,796.80 with increased annual cost of \$3,600 not including sales tax. Compensation after module implementation will not exceed \$12,000 per year. The term continues until terminated. All other terms and conditions of the original Agreement shall remain in effect.

e) PROSECUTING ATTORNEY:

7. Settlement Agreement and Release with United States Fidelity and Guaranty Company and St. Paul Surplus Lines Insurance Company for the former Whitmarsh Landfill Site. \$393,042.80 will be paid to Skagit County to pay for costs associated with the Clean-up Action Plan approved by the Washington State Department of Ecology. The Agreement shall be effective upon signature of all parties.

f) PUBLIC HEALTH:

- 8. Personal Services Agreement with United General District 304 to continue capacity building to create a comprehensive, coordinated system of early learning supports and resources for families with young children. Compensation shall not exceed \$47,000. The Agreement is ratified to commence on May 15, 2023 and shall continue until May 31, 2024.
- 9. Agreement with Washington State Department of Social and Health Services on General Terms and Conditions that will govern work to be performed under any Program Agreement between Skagit County and the Department of Social and Health Services. There is no compensation associated with this Agreement. The Agreement shall commence on July 1, 2023 and continue until June 30, 2029.
- 10. Amendment No. 1 to Collaboration Agreement No. C20220273 with Bright by Text, a national non-profit organization that provides ongoing free informational text messages to parents and caregivers of children prenatal to age eight (8) subscribers. This Amendment extends the term of the Agreement from May 31, 2023 to continue until May 31, 2025 and increases compensation by \$18,000 for a new total compensation amount not to exceed \$28,000. All other terms and conditions of the original Agreement shall remain in effect.
- 11. Amendment No. 2 to Personal Services Agreement No. C20220284 with Community Action of Skagit County to operate the Housing Resource Center as the primary Coordinated Point of Entry for Skagit County's homelessness services. This Amendment extends the term of the Agreement from June 30, 2023 to January 31, 2024 and increases compensation by \$163,701, total compensation shall not exceed \$444,331. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 12. Amendment No. 2 to Contract No. C20230066 with Northwest Regional Council (242018-NUTR) to provide meals and nutritional support through Congregate and Home Delivered Meals. This Amendment updates "Exhibit A" to include the Seniors Farmers Market Nutrition Program (SFMNP). Compensation remains the same and shall not exceed \$493,855. The term remains the same and shall continue until December 31, 2023. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

g) PUBLIC WORKS:

- 13. Vendor Services Agreement with North Point Metalworks to provide services and products to upfit one Skagit County Health Department full size cargo van per specifications provided by Skagit County. Compensation shall not exceed \$59,868.47. The Agreement shall commence on the date of execution and continue for one year.
- 14. Vendor Services Agreement with Northwest Grouting, LLC to provide a dive team on Fonk Road to inspect the existing culvert for measurement and engineering purposes to determine the appropriate size of liner for the culvert rehabilitation. Compensation shall not exceed \$10,000. The Agreement shall commence on the date of execution and continue for one year.

h) RISK MANAGEMENT:

15. Personal Services Agreement with Summit Law Group PLLC to provide training, representation and assistance on matters related to employment law, labor relations/negotiations, and litigation. Compensation shall not exceed \$75,000 and is based on a fee schedule. The Agreement is ratified to commence on January 1, 2023 and shall continue until December 31, 2023.

i) SHERIFF:

16. Amendment No. 2 to Personal Services Agreement No. C20190168 with RDP Unlimited, LLC to provide background and interview services for potential and existing employees of the Skagit County Sheriff's Office and the Skagit County Community Justice Center. This Amendment increases compensation from \$25,000 per calendar year to an amount not to exceed \$35,000 per calendar year and is based on a fee schedule. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
