Amendment No. 3 to Interlocal Cooperative Agreement No. C20200455 with SkagitNet, LLC to award \$839,437.80 of Economic Development/Public Facilities Project grant funds to support the completion of the Skagit County Fiber Optic Network - Segment 4. This Amendment extends the contract completion date from June 30, 2023 to December 31, 2023 to allow the Recipient sufficient time to complete the construction and closeout procedures of the Project. There is no additional compensation associated with this Amendment. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

The term remains the same and shall continue until June 30, 2023. All other terms and conditions of the original Agreement shall remain in effect.
- 7. Amendment No. 1 to Agreement No. C20230019 with The Salvation Army to provide Disaster Case Management services for persons displaced from their residences as a result of damages incurred by the continuous series of severe winter storms, high winds, flooding, landslides and mudslides in November and December of 2021. This Amendment increases compensation from \$80,312 to an amount not to exceed \$93,833. All other terms and conditions of the original Agreement shall remain in effect.

All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 17. Data Sharing Agreement for Confidential Information Dataset(s) with the State of Washington Department of Health and Skagit County to document the conditions under which the Washington State Department of Health shares confidential information or limited datasets with other entities regarding the health needs of the community, including COVID-19, secondary data review for trending and analysis to support health programs, death, and birth rates. The Agreement shall commence on the date of execution and continue until April 30, 2028.
- 18. Amendment No. 4 to Personal Services Agreement No. C20210383 with Lifeline Connections to provide case management and recovery support services to individuals enrolled in Skagit County Adult Felony and Drug Court. This Amendment adds reimbursement for services which are not eligible for reimbursement by Medicaid or private insurance for a new compensation amount not to exceed \$415,995. The term remains the same and shall continue until June 30, 2023. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 19. Amendment No. 3 to Contract No. C20230066 with Northwest Regional Council (242018-NUTR) to provide meals and nutritional support through Congregate and Home Delivered Meals. This Amendment updates funding levels for the Senior Nutrition Program for a new compensation amount not to exceed \$514,866. The term remains the same and shall continue until December 31, 2023. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 20. Amendment No. 1 to Personal Services Agreement No. C20230111 with Hand Crank Films to help Skagit County engage, educate, and inform the community about the North Star Project and convey critical messages about homelessness and behavioral health. Total compensation shall not exceed \$70,000 which is based on a fee schedule and is funded by annual assessments collected from the residents of LMD 1. The Agreement is ratified to commence on June 1, 2023 and continue until May 31, 2024.
- 31. Personal Services Agreement with Northwest Aquatic Eco-Systems to provide aquatic plant management services for Lake Management District No. 2 for Lake McMurray (LMD 2) to continue implementing the control strategy to manage noxious aquatic plants such as Eurasian milfoil and control fragrant water lilies with herbicides and a mechanical harvester in Lake McMurray. Total compensation shall not exceed \$19,000 which is based on a fee schedule and is funded by annual assessments collected from the residents of LMD 2. The Agreement is ratified to commence on June 1, 2023 and continue until May 31, 2024.
- 32. Personal Services Agreement with Northwest Aquatic Eco-Systems to provide aquatic plant management services for Lake Management District No. 4 for Clear Lake and Beaver Lake (LMD 4) to continue

implementing the control strategy to manage noxious aquatic plants such as Eurasian milfoil, fragrant water lilies, and other nuisance aquatic vegetation in Clear Lake and Beaver Lake. Total compensation shall not exceed \$23,000 which is based on a fee schedule and is funded by annual assessments collected from the residents of LMD 4. The Agreement is ratified to commence on June 1, 2023 and continue until May 31, 2024.

- 33. Vendor Services Agreement with Gardner Electronics for Public Works vehicle upfitting, including but not limited to Sheriff vehicles and Public Works vehicles. Compensation was awarded by Resolution No. R20230085 shall not exceed \$135,000. The Agreement shall commence on the date of execution and continue for an initial term of three (3) years with the option to be extended for one (1) additional year.
- 34. Vendor Services Agreement with Northwest Center Services dba Lithtex NW to print ferry tickets for the Skagit County ferry system. Compensation is based on a rate schedule and shall not exceed \$9,999. The Agreement is ratified to commence on May 26, 2023 and continue for an initial term of one (1) year with the option to be extended for one (1) additional year.
- 35. Amendment No. 2 to Personal Services Agreement No. C20220244 with GeoTest Services Inc. for Professional Engineering services and Materials Testing services on an as-needed basis for non-federally funded capital road projects. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
