Interlocal Cooperative Agreement with Skagit County Fire Protection District #8 to provide a secure and accessible site for placement of a County election ballot drop box on Fire District #8's property located at 34041 State Route 20 in Hamilton for voters to deposit ballots during elections. The County shall be responsible for the maintenance and repair of the ballot box as well as regular collection of ballots during various election cycles. There is no monetary value associated with this Agreement. The Agreement shall commence on the date that the last party signs the Agreement and continue until terminated.
- 4. Vendor Services Agreement with Hart Intercivic to provide equipment and software for the Election Tabulation System Upgrade. Compensation shall not exceed \$66,909.61. The Agreement is ratified to commence on June 1, 2023 and continue for one year.

c) EMERGENCY MANAGEMENT:

5. Amendment No. 1 to Vendor Services Agreement No. C20220321 with Western Shelter for the purchase of HazMat equipment in the amount of \$41,000 through funding contract with the Washington State Department of Ecology, Contract No. C20220175. This Amendment increases funding by \$500 for a new total compensation amount not to exceed \$41,500. All other terms and conditions of the original Agreement shall remain in effect.

d) FACILITIES MANAGEMENT:

- 6. Memorandum of Office Lease Agreement with Pacific Northwest Properties 1, LLC for the purpose of establishing Skagit County's (Tenant) option to purchase (Purchase Option) the building leased to occupy 17,993 sf of office space at 301 Valley Mall Way in Mount Vernon, Skagit County Contract No. C20230243. The Agreement shall commence on the date of execution and continue for the 15-year lease term starting on the first day of occupancy.
- 7. Amendment No. 2 to Lease Agreement No. C20170483 with Eagles Nest View LLC to lease premises located at 1129 Dale Lane, Unit A, in Mount Vernon to provide storage for Skagit County records. This Amendment extends the term from October 31, 2023 to continue until April 30, 2024, and increases rent by \$66 per month, to a new monthly lease rate of \$1,391 per month. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

e) GEOGRAPHIC INFORMATION SERVICES:

- 8. Interlocal Cooperative Agreement with Public Utility District No. 1 of Skagit County to establish a cost sharing partnership for Pictometry digital imagery services. Compensation to Skagit County shall not exceed \$12,500 plus tax for the flights, and \$480 per year for ten Pictometry Connect Explorer licenses which may change in 2024 depending on the agency's needs. Total compensation to Skagit County is estimated at an amount not to exceed \$28,135 plus tax. The Agreement shall commence on the date of execution and continue for two years.
- 9. Interlocal Cooperative Agreement with the Port of Anacortes to establish a cost sharing partnership for Pictometry digital imagery services. Compensation to Skagit County shall not exceed \$5,000 plus tax for the flights, and \$96 per year for two Pictometry Connect Explorer licenses which may change in 2024 depending on the agency's needs. Total compensation to Skagit County is estimated at an amount not to exceed \$11,062 plus tax. The Agreement shall commence on the date of execution and continue for two years.
- 10. Interlocal Cooperative Agreement with Seattle City Light to establish a cost sharing partnership for Pictometry digital imagery services. Compensation to Skagit County shall not exceed \$12,500 plus tax for the flights, and \$192 per year for four Pictometry Connect Explorer licenses which may change in 2024 depending on the agency's needs. In addition to the base fee, the Agency has requested to extend the imagery area by an additional 29 square miles and therefore shall pay an additional \$1,740 per year. Total compensation to Skagit County is estimated at an amount not to exceed \$31,342 plus tax. The Agreement shall commence on the date of execution and continue for two years.
