c) PUBLIC HEALTH:

- 6. Personal Services Agreement with Dreamcatcher Facilitation Services to provide Person-Centered-Planning (PCP) services to youth, families, and school district staff throughout Skagit County for the purpose of helping families and school district staff partner around the special planning needs of transition-age youth enrolled in the Skagit County Bridges Program or other transition-age students approved by the County. Compensation is based on a rate schedule and shall not exceed \$20,000. The Agreement is ratified to commence on July 1, 2024 and continue until June 30, 2025.
- 7. Personal Services Agreement with Skagit Preschool and Resource Center (SPARC) to provide outreach, information and support to families that have a family member who experiences a developmental disability through the Parent-to-Parent program. Compensation shall not exceed \$82,000. The Agreement is ratified to commence on July 1, 2024 and continue until June 30, 2025.
- 8. Subrecipient Agreement with Catholic Community Services of Western Washington to implement a program to provide recovery services to individuals with a substance use disorder or who have history of substance use problems through a grant from Washington State Health Care Authority (HCA Contract No. K6105, Skagit County Contract No. C20220326). Skagit County shall pass through to Catholic Community Services of Western Washington an amount not to exceed \$146,000. The Agreement is ratified to commence on July 1, 2024 and continue until June 30, 2025.
- 9. Personal Services Agreement with Skagit Valley Hospitality Association dba Friendship House to manage and oversee the operation and provision of support services delivered at the shelter site owned and provided by the City of Burlington located at 465 Pease Road. Compensation shall not exceed \$577,500. The Agreement is ratified to commence on July 1, 2024 and continue until June 30, 2025.
- 10. Interlocal Cooperative Agreement with Conway School District to increase school attendance and academic achievement by maintaining programs and practices that prevent or reduce substance use/disorders, that target mental health promotion, prevention, and treatment, and provide workforce development opportunities for district employees addressing behavioral, social and emotional determinants of health and learning. Compensation from Skagit County shall not exceed \$37,000. The Agreement is ratified to commence on August 1, 2024 and continue until July 31, 2025.
- 11. Personal Services Agreement with Hand Crank Films for videography services including the planning, coordination and production of five short videos about North Star and humanize its impact through stories and videos. Compensation shall not exceed \$26,000. The Agreement is ratified to commence on August 15, 2024 and shall continue until December 31, 2025.
- 12. Personal Services Agreement with Housing Authority of Skagit County to provide emergency shelter and tenant-based rental assistance to farmworkers and their families who are homeless or at risk of being homeless. Compensation shall not exceed \$32,230. The Agreement is ratified to commence on July 1, 2024 and shall continue until June 30, 2025.
- 13. Personal Services Agreement with Lifeline Connections to provide case management and recovery support services to individuals enrolled in Skagit County Adult Felony Drug Court. Compensation shall not exceed \$250,000. The Agreement is ratified to commence on July 1, 2024 and shall continue until June 30, 2025.
- 14. Amendment No. 4 to Personal Services Agreement No. C20230044 with Helping Hands Project Organization to administer the Consolidated Homeless Grant Eviction Prevention Program. This Amendment increases compensation from \$636,169.39 to an amount not to exceed \$848,009.39. The term remains the same and shall continue until June 30, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
