- 1. Record of the Proceedings for Monday, August 21, 2023.
- 2. Resolution approving the appointment of Glen Gardner as the ALS Transport Provider #1 Representative member of the Skagit County Emergency Medical Services and Trauma Care Council Advisory Board for a three-year term ending on August 31, 2026.
- 3. Resolution approving the appointment of Wood Weiss as the BLS Transport Provider Representative member of the Skagit County Emergency Medical Services and Trauma Care Council Advisory Board for a three-year term ending on February 28, 2026.
- 4. Resolution approving the appointment of Paul Ross as the Local Hospital Representative member of the Skagit County Emergency Medical Services and Trauma Care Council Advisory Board. Paul Ross shall fill the unexpired term of Kandi Devenere. Mr. Ross's term shall end on February 29, 2024.
- Resolution approving the appointment of Velma Lockrem as the Law Enforcement Representative member of the Skagit County Emergency Medical Services and Trauma Care Council Advisory Board for a three-year term ending on August 31, 2026.
- 6. Interlocal Cooperative Agreement between Skagit County, and the Cities of Mount Vernon, Anacortes, Burlington and Sedro-Woolley to formally establish the North Star Leadership Team for Skagit County for the study of housing, homelessness, and behavioral health. The purpose of this Agreement is to provide a forum allowing local jurisdictions with mutual interests to alleviate impacts to homelessness, housing, behavioral health, and substance use disorders through their respective authorities to develop both well informed and coordinated actions that cumulatively form a regional system that provides methods to eliminate, reduce and/or effectively manage such issues. The Agreement shall commence on the date of the last party affixing its signature. There is no compensation associated with this Agreement.

b) FACILITIES MANAGEMENT:

- 7. Amendment No. 1 to Vendor Services Agreement No. C20200396 with Guardian Security Inc. to provide all labor, materials, equipment, and supervision for the AES Lease, Fire & Security Intrusion Alarm Monitoring Services at Skagit County Facilities. This Amendment increases compensation by an additional \$40,000 to provide AES Lease and Intrusion Alarm Monitoring at additional Skagit County Facilities for a new compensation amount not to exceed \$90,000. The term remains the same and shall continue until August 23, 2025. All other terms and conditions of the original Agreement shall remain in effect.
- 8. Vendor Services Agreement with Cascade Roofing Company, Inc. to provide all labor, materials, equipment, and supervision for roof repairs at various Skagit County Facilities. Compensation is based on a rate schedule and shall not exceed \$30,000 including applicable tax. The Agreement shall commence on the date of execution and continue for one year with the option to extend for one additional year.

c) **HUMAN RESOURCES:**

- 9. Vendor Services Agreement with Kelley's BBQ to prepare, deliver, and serve meals for the Skagit County All-Staff Summer Event. Compensation shall not exceed \$5,000. The Agreement shall commence on the date of execution and continue for one year.
- 10. Vendor Services Agreement with Cocina Sabores and Catering to prepare, deliver, and serve meals for the Skagit County All-Staff Summer Event. Compensation shall not exceed \$4,000. The Agreement shall commence on the date of execution and continue for one year.
- 11. Amendment No. 1 to Collective Bargaining Agreement No. C20220190 between the Board of County Commissioners, Skagit County Sheriff and Skagit County Sheriff's Office Staff Guild/Washington State Fraternal Order of Police.

d) INFORMATION SERVICES:

- 12. Amendment No. 3 to Subscription Agreement No. C20190427 with Justice Works, LLC, formerly known as defender Data, LLC, for the provision of software for a Public Defender Case Management System. This Amendment upgrades the software to the Defender Prime system. Compensation is increased by an additional \$30,000 to perform data conversion and configuration changes for a new compensation amount not to exceed \$124,800. The term remains the same and shall continue until September 30, 2025. All other terms of the original Agreement and prior Amendments shall remain in effect.
- 13. Request for Proposals (RFP) to replace Skagit County's Backup and Recovery System. The closing time and date for proposals to be submitted to the Skagit County Commissioners' Office shall be Thursday, October 12, 2023 at 3:30 p.m.

14. Contract with CDW-G to provide Microsoft Volume Licensing to continue using Microsoft products with updates and support. Compensation is estimated to not exceed \$475,000 per year for the core contract. Compensation is estimated to not exceed \$1,425,000 for the 3-year period. The Agreement shall commence on the date of execution and continue for three years.

e) PUBLIC HEALTH:

- 15. Interlocal Cooperative Agreement with Conway School District to increase school attendance and academic achievement by maintaining programs and practices that prevent or reduce substance use/disorders, that target mental health promotion, prevention, and treatment, and provide workforce development opportunities for district employees addressing behavioral, social and emotional determinants of health and learning. Compensation from Skagit County shall not exceed \$37,000. The Agreement is ratified to commence on August 1, 2023 and continue until July 31, 2024.
- 16. Personal Services Agreement with Work Opportunities, Inc. to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a rate schedule and shall not exceed \$7,500. The Agreement is ratified to commence on August 1, 2023 and continue until July 30, 2024.
- 17. Interagency Agreement with Washington State Department of Ecology, IAA No. C2400049, to provide Pollution Prevention Assistance Specialists who will provide technical assistance and education outreach to small businesses in an effort to prevent pollution of waters of the state as part of the Pollution Prevention Assistance Partnership (formerly known as the Local Source Control (LSC) Partnership). Compensation to Skagit County shall not exceed \$305,750. The Agreement is ratified to commence on July 1, 2023, and shall continue until June 30, 2025.
- 18. Interlocal Cooperative Agreement with the Samish Indian Nation to distribute low-income housing funds pursuant to Substitute House Bill 2163. Compensation shall not exceed \$43,901.70. The Agreement is ratified to commence on July 1, 2023 and continue until July 30, 2024.
