Interlocal Cooperative Agreement with Burlington-Edison School District to fund a master's level school social worker in order to develop and support a Multi-Tiered System of Support (MTSS) practice and teams, increase capacity to implement or maintain programs and practices that reduce substance use/disorders that target mental health promotion, prevention, and treatment, and provide workforce development opportunities for district employees addressing behavioral, social and emotional determinants of health and learning. Compensation shall not exceed \$77,000. The Agreement is ratified to commence on August 1, 2023 and continue through July 31, 2024.
- 20. Subrecipient Agreement with Catholic Community Services of Western Washington to implement a program to provide recovery services to individuals with a substance use disorder or who have history of substance use problems through a grant from Washington State Health Care Authority (HCA Contract No. K6105, Skagit County Contract No. C20220326). Skagit County shall pass through to Catholic Community Services of Western Washington an amount not to exceed \$186,667 in Substance Abuse Prevention and Treatment Block Grant (SABG) funds. The Agreement is ratified to commence on July 1, 2023 and continue until June 30, 2024.
- 21. Amendment No. 1 to Personal Services Agreement No. C20230314 with Community Action of Skagit County to provide short-term rental assistance for households at imminent risk of homelessness through a Targeted Prevention model that will serve those households most likely to become homeless without assistance. This Amendment adds GL expenditure codes 165-596-0205-4110, 165-596-0207-4110, and other GL codes as necessary, updates Exhibit "B", Scope of Work and increases compensation from \$851,874 to an amount not to exceed \$1,080,082 for personnel, facility support, direct client services, and administrative expenses.
