d) FACILITIES MANAGEMENT:

8. Personal Services Agreement with Whatcom Environmental Services, Inc. to provide hazardous material surveys and testing at multiple Skagit County locations as designated by the Facilities Management Department. Compensation shall not exceed \$15,000 plus applicable taxes. The Agreement shall commence on November 1, 2022 and continue until October 31, 2024.

e) INFORMATION SERVICES:

9. Agreement with Right Systems Inc. for a one (1) year renewal for a subscription to the OKTA Authentication platform. Compensation shall not exceed \$40,997.44. The Agreement is ratified to commence on September 19, 2022 and continue until September 18, 2023.

f) OFFICE OF JUVENILE COURT:

10. Interlocal Cooperative Agreement with Sedro-Woolley School District to jointly fund the BECCA Case Manager position to serve the School District and the Skagit County Office of Juvenile Court in implementing the truancy portion of the BECCA bill as outlined by RCW and WAC. Compensation to Skagit County shall not exceed \$6,232. The Agreement is ratified to commence on September 1, 2022 and continue through August 31, 2023.

g) PARKS, RECATION AND FAIR:

11. Personal Services Agreement with Washington Trails Association to provide trail maintenance volunteers, tools, and crew leaders to train them in the techniques of trail maintenance and construction for ten (10) work events at Sharpe Park/Montgomery-Duban Headlands, and other Skagit County Parks as assigned. Compensation is based on a fee schedule and shall not exceed \$14,000. The Agreement shall commence on the date of execution and continue until December 31, 2023.

h) PUBLIC HEALTH:

- 12. Personal Services Agreement with Youthnet to support perinatal mental health by providing direct support for parents and families experiencing Perinatal Mood and Anxiety Disorders (PMADs), in accordance with Skagit County Contract No. C20220305 (Exhibit "D") with the Department of Children, Youth and Families (DCYF), DCYF Contract No. 23-1080. Compensation is based fee schedule and shall not exceed \$6,000. The Agreement is ratified to commence on September 12, 2022 and continue until June 30, 2023.
- 13. Personal Services Agreement with Skagit Valley Hospitality Association dba Friendship House to repair and

update sewer and plumbing at a facility located at 922 South 3rd Street in Mount Vernon that serves as an emergency shelter to women and children. Compensation is based on reimbursement for eligible repair and upgrade expenses and shall not exceed \$10,000. The Agreement is ratified to commence on September 1, 2022 and continue until December 31, 2022.

- 14. Interlocal Cooperative Agreement with the City of Mount Vernon to fund an emergency low-barrier shelter program for individuals with moderate to severe behavioral health disorders and are homeless or at risk of becoming homeless. Compensation is funded through a Department of Commerce CARES Act Emergency Solutions Grant, Skagit County Contract C20200355 and shall not exceed \$15,000. The Agreement is ratified to commerce on August 1, 2022 and continue until April 30, 2023.
- 15. Interlocal Agreement with North Sound Behavioral Health Administrative Services Organization, LLC (North Sound BH-ASO) Contract #North Sound BH-ASO-Skagit County-Interlocal-22 to provide coordination and subcontracting services for programs and services including Dedicated Marijuana Account Program, Jail Services Program, Trueblood, and the Co-Responder Program. Compensation to Skagit County shall not exceed \$196,613.83. The Agreement is ratified to commence on July 1, 2022 and continue until December 31, 2022.
- 16. Personal Services Agreement with Sherwood Community services to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a fee schedule and shall not exceed \$15,000. The Agreement is ratified to commence on August 1, 2022 and continue until July 31, 2023.
- 17. Personal Services Agreement with Transmediavision USA, Inc. to convey critical messages to the public regarding priority Public Health issues and concerns. Compensation is based on a fee schedule and shall not exceed \$15,000. The Agreement is ratified to commence on September 12, 2022 and continue until August 31, 2023.
- 18. Personal Services Agreement with Washington Vocational Services to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a fee schedule and shall not exceed \$15,000. The Agreement is ratified to commence on August 1, 2022 and continue until July 31, 2023.
- 19. Personal Services Agreement with New Earth Recovery to operate a Recovery Café located in the City of Mount Vernon and provide comprehensive recovery support services to individuals aged 16 and older who are working toward recovery from mental health, substance use, and co-occurring disorders. Compensation is based on a fee schedule and shall not exceed \$380,000. The Agreement is ratified to commence on September 1, 2022 and continue until October 31, 2024.
- 20. Amendment No. 3 to Personal Services Agreement No. C2o2oo687 with Catholic Community Services of Western Washington to provide homeless outreach, case management, and shelter services according to the guidelines of Washington State Department of Commerce's most recent CARES Act Emergency Solutions Grant COVID-19 (ESG-CV) Guidelines as posted on the website. This Amendment decreases total compensation from \$966,690 to an amount not to exceed \$951,609. The term is extended from September 30, 2022 to December 31, 2022. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 21. Amendment No. 2 to Senior Nutrition Services contract No. C20220341 with Northwest Regional Council, Contract No. 241018-NUTR, for the provision of funding for the senior services nutrition program including congregate and home-delivered meals for seniors in Skagit County. This Amendment reduces compensation from \$377,149 to an amount not to exceed \$361,080. The term remains the same and shall continue until December 31, 2022. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
