Amendment No. 1 to Interlocal Cooperative Agreement No. C20210284 with the Town of Concrete to award \$400,000 of Economic Development/Public Facilities Projects grant funds to support Secondary Access. This Amendment extends the term of the Agreement from December 31, 2023 to December 31, 2024. There is no additional compensation with this Amendment. All other terms and conditions of the original Agreement shall remain in effect.

This Amendment incudes Skagit County Public Hospital District No. 304 as a party to the Agreement, updates duties and responsibilities to be performed, manner of financing and extends the term of the Agreement to continue until August 31, 2026. All other terms and conditions of the original Agreement shall remain in effect.

g) PUBLIC HEALTH:

- 12. Personal Services Agreement with Anacortes School District to develop and maintain the Multi-Tiered System of Support (MTSS) practice and teams with the shared goals of increasing school attendance, academic achievement and addressing social and emotional determinates of health and learning. Compensation shall not exceed \$90,000. The Agreement is ratified to commence on September 1, 2023 and continue until August 31, 2024.
- 13. Personal Services Agreement with Mount Vernon School District to develop and maintain the Multi-Tiered System of Support (MTSS) practice and teams with the shared goals of increasing school attendance, academic achievement and addressing social and emotional determinates of health and learning. Compensation shall not exceed \$80,000. The Agreement is ratified to commence on September 1, 2023 and continue until August 31, 2024.
- 14. Personal Services Agreement with Pioneer Human Services to provide consultation services to support development of the Skagit County Crisis Stabilization Center. Compensation shall not exceed \$16,000 and is

- based on a rate schedule. The Agreement is ratified to commence on October 1, 2023 and continue until October 31, 2024.
- 15. Personal Services Agreement with Family Promise of Skagit Valley to plan, manage, and operate a low-barrier temporary, seasonal drop-in shelter at the Bethlehem Lutheran Church in Sedro-Woolley. Compensation shall not exceed \$89,880. The Agreement shall commence on November 1, 2023 and continue until April 30, 2024.
- 16. Amendment No. 1 to Personal Services Agreement No. C20230290 with Northwest Youth Services to provide diversion services to young adults aged 18-24, including one-time support, short-term services, and financial assistance to households who qualify for homeless services but can be diverted away from shelter and the homeless service system with immediate financial assistance. This Amendment updates the scope of work to comply with the Washington State Department of Commerce's most recent Consolidated Homeless Grant Guidelines. Compensation remains the same and shall not exceed \$89,777. The term remains the same and shall continue until June 30, 2024. All other terms and conditions of the original Agreement shall remain in effect
- 17. Amendment No. 1 to Personal Services Agreement No. C20230291 with Northwest Youth Services to operate a Transitional Living Program and provide at least 15 beds to homeless and runaway youth aged 16-24. This Amendment updates the scope of work to comply with the Washington State Department of Commerce's most recent Consolidated Homeless Grant Guidelines. Compensation remains the same and shall not exceed \$131,447. The term remains the same and shall continue until June 30, 2024. All other terms and conditions of the original Agreement shall remain in effect.
- 18. Amendment No. 2 to Personal Services Agreement No. C2o23oo44 with Helping Hands Project Organization to administer the Consolidated Homeless Grant Eviction Prevention Program to prevent evictions by providing outreach services and application preparation, review, and submission for marginalized communities. This Amendment increases compensation from \$295,029 to an amount not to exceed \$347,273. The term remains the same and shall continue until June 30, 2024. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 19. Amendment No. 2 to Personal Services Agreement No. C20230054 with Skagit Legal Aid to provide homelessness prevention support to households who are most at risk of homelessness. This Amendment increases compensation from \$64,500 to an amount not to exceed \$97,750. The term remains the same and shall continue until June 30, 2024. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.

Agreement with the State of Washington Department of Ecology, Agreement No. SPPRCPF-2023-SkCoPW-00011, for the removal of 24 creosote pilings from within Hart Slough and the floodplain and to restore 4.15 acres of riparian habitat along the slough. Compensation to Skagit County shall not exceed \$45,880. The Agreement is ratified to commence on August 7, 2023 and continue until January 31, 2025.
- 22. Interlocal Cooperative Agreement with Skagit Conservation District to allow the County to work with the District on a reimbursable basis for assistance to be provided by the District to the County in meeting Voluntary Stewardship Program enhancement goals through implementation of site-specific projects. The following District projects will be funded: Cover Crop Program for the provision of grants to landowners to purchase cover crop seeds for the 2023 and 2024 planting season. Compensation shall not exceed \$50,000. The Agreement is ratified to commence on September 1, 2023 and continue until June 30, 2025.
- 23. Interlocal Cooperative Agreement with Skagit Conservation District to allow the County to work with the District on a reimbursable basis for assistance to be provided by the District to the County in meeting Voluntary Stewardship Program enhancement goals through implementation of site-specific projects. The following District projects will be funded: Skagit River Maple LLC invasive plant removal, hedgerow wetland planting, and forest restoration; and Stewart invasive plant removal and reforestation along the slough. Compensation shall not exceed 54,050. The Agreement shall commence on the date of execution and continue until June 30, 2025.
- 24. Amendment No. 1 to Vendor Services Agreement No. C20230100 with ProScapes, Inc. to provide landscaping maintenance for divisions in Public Works to include the Conway Roundabout, South LaVenture Median, and the Solid Waste Transfer Station. This Amendment increases compensation by \$39,521.58 for a new total compensation amount not to exceed \$79,043.16 and extends the term of the Agreement from February 28, 2024 to February 28, 2025. 25.
