7. Amendment No. 1 to Interlocal Cooperative Agreement No. C20250090 with Port of Skagit for the Bow Outlying Areas Broadband Project. Matching funds will be provided to the Port to build approximately 36 miles of new fiber in the Community of Bow, WA. This Amendment extends the term of the Agreement from December 31, 2025, to December 31, 2026. Compensation to the Port remains the same and shall not exceed \$894,917. All other terms and conditions of the original Agreement shall remain in effect.

#### c) ASSIGNED COUNSEL:

8. Personal Services Agreement with Snohomish County Public Defender Association to provide consultation and representation for cases considered to be conflict of interest cases for the Skagit County Public Defender's Office and that have been determined to be within the scope of indigent defense. Case referrals will be from Superior Court, Juvenile Court, and District Court. Compensation is based on a rate schedule and shall not exceed \$517,290. The Agreement shall commence on January 1, 2026, and continue until December 31, 2026.

#### d) FACILITIES MANAGEMENT:

- 9. Amendment No. 3 to AIA Standard Form Agreement No. C2o25o059 with TRICO Companies to provide all labor, materials, and supervision services for tenant improvements on the 3<sup>rd</sup> floor of the Administration Building located at 700 South 2<sup>nd</sup> Street in Mount Vernon. This Amendment updates the Scope of Work to reflect floorplan changes needed once conditions were exposed or identified during the course of work. Compensation is increased from \$2,448,505 to an amount not to exceed \$2,554,170 plus applicable tax. The term remains the same and shall continue until December 31, 2025.
- 10. Personal Services Agreement with Certerra Northwest LLC dba GeoTest Services, Inc. for forensic investigation and to provide a summary report of the existing building enclosure and systems to determine the cause(s) of moisture intrusion and/or condensation issues affecting the Public Safety Building, located at 600 South 3<sup>rd</sup> Street in Mount Vernon. Compensation is based on a fee schedule and shall not exceed \$13,490. The Agreement is ratified to commence on September 15, 2025, and continue until December 31, 2025.

#### e) HUMAN RESOURCES:

11. Amendment No. 2 to Collective Bargaining Agreement No. C20250305 between Skagit County and Professional and Technical Employees (PROTEC 17): Department of Emergency Management (DEM), Public Health, Geographic Information Services (GIS), and Planning and Development Services. This Amendment updates Article 5 - Health and Welfare, effective January 1, 2026. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect including the term which continues through December 31, 2026.

#### f) INFORMATION SERVICES:

- 12. Personal Services Agreement with Whatcom Law Group, P.S. to provide Hearing Examiner Services. Compensation is based on rate schedule and shall not exceed \$11,000 per month with a 5% increase each year. The Agreement shall commence on January 1, 2026, and continue until December 31, 2031.
- 13. Software License Agreement with Justice Works LLC to provide the defender Data Prime System for the Public Defender's Office Case/Docket Management System. Compensation is based on a monthly caseload subscription fee of \$3.75/case for FY2026, and \$3.90/case for FY2027. The Agreement shall commence on the date of execution and continue for two (2) years.

- 14. Vendor Services Agreement with NW Tel, Inc. to provide all labor and material for the addition of networking infrastructure at the Skagit County Guemes Island Ferry terminal. Compensation shall not exceed \$4,000. The Agreement shall commence on the date of execution and continue for one (1) year.
- 15. Cooperative Purchasing Contract Authorization with Pacific Office Automation to purchase copiers, printers, multi-functional devices and related solutions through a Contract with Sourcewell, Contract No. 112124-CAN with Canon USA, Inc. Compensation shall not exceed \$23,500. The Agreement shall commence on the date of execution and continue until January 10, 2029.

#### g) PARKS, RECREATION, AND FAIR:

- 16. Amendment No. 1 to Personal Services Agreement No. C20240379 with Reid Middleton, Inc. to provide engineering design services for the Skagit County Guemes Island Trail Project. This Amendment extends the term of the Agreement from December 31, 2025, to December 31, 2026. Compensation remains the same and shall not exceed \$35,000. All other terms and conditions of the original Agreement shall remain in effect.
- 17. Amendment No. 3 to Personal Services Agreement No. C20220201 with Reid Middleton, Inc. to provide renovation design and construction cost estimates for the Swinomish Boat Launch. This Amendment extends the term of the Agreement from December 31, 2025, to December 31, 2026. Compensation remains the same and shall not exceed \$82,500. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 18. Real Estate Purchase and Sale Agreement with Skagit Land Trust for the purchase of real property known as Skagit County Assessor Tax Parcel Numbers P27655, P27651, P27660, and P27661 by Skagit County for the Big Rock Yudwasta Park. Compensation to seller shall not exceed \$1,400,000. The Agreement shall commence on the date of execution.

#### h) PROSECUTING ATTORNEY:

19. Resolution to provide legal defense to Skagit County employee Thomas Wenzl in a lawsuit identified by Case Number 25-cv-01304, Larry R. Jensen, Tulip Valley Farms, LLC v. Skagit County.

# i) PUBLIC HEALTH:

- 20. Personal Services Agreement with True Measure Collaborative to provide technical assistance, training and coaching to school districts in Skagit County with a focus on improving educational outcomes for students with disabilities and/or multilingual learning. Compensation is based on a fee schedule and shall not exceed \$45,000. The Agreement is ratified to commence on October 1, 2025, and shall continue until June 30, 2026.
- 21. Technical Assistance Recipient Agreement with Ginger Segal Consulting, dba GS Consulting LLC, to provide services for the assessment of the Mount Vernon Senior Center, located at 1401 Cleveland Avenue in Mount Vernon. The purpose of the assessment is to explore redevelopment by a non-profit or housing authority as either a multifamily residential project or a mixed-use project that includes affordable rental housing, a replacement senior center, and commercial kitchen space for the Meals on Wheels program. The Agreement is ratified to commence on May 15, 2025, and will continue until January 31, 2026. Compensation shall not exceed \$25,000 and is funded by the Washington State Department of Commerce.
- 22. Interagency Agreement with the Washington State Health Care Authority (HCA) Contract No. K8536 for Criminal Justice Treatment Account (CJTA) Funded Treatment and Recovery Services. Compensation to Skagit County shall not exceed \$540,586. The Agreement is ratified to commence on July 1, 2025, and continue until June 30, 2027.
- 23. Amendment No. 1 to Facility Use Agreement No. C20250488 with Welcome Home Skagit (WHS). This Amendment increases the available number of pallets from five (5) to six (6). There is no compensation associated with this Amendment or the original Agreement. The term remains the same and shall continue until October 5, 2030. All other terms and conditions of the original Agreement shall remain in effect.

# j) PUBLIC WORKS:

24. Landowner Agreement with Rachel C. Perlot and Jack Conger to remove invasive plants to enhance the riparian habitat and improve water quality on Colony Creek near the headwaters at 17791 Colony Road in Bow. Compensation will be funded by the Washington State Conservation Commission (SCC) 2025-27 Biennium Contract No. K2625 and pursuant to Skagit County Agreement No. C20250304, as amended by Amendment Nos. A20150165, A20250198, A20250199, A20250200. The Agreement is ratified to commence on September 1, 2025, and continue until June 30, 2027.

- 25. Amendment No. 1 to Vendor Services Agreement No. C20250238 with IMAC General Construction, Inc., dba Fusion Lining Services, to provide welding services at the Skagit County Transfer and Recycling Station and its satellite sites (Sauk and Clear Lake). This Amendment increases compensation from \$39,000 to an amount not to exceed \$89,000, due to equipment requiring welding repairs. The term remains unchanged and shall continue until May 1, 2027. All other terms and conditions of the original agreement shall remain in effect.
- 26. Interlocal Cooperative Agreement with Skagit Conservation District to allow the District to provide financial assistance to the County on a reimbursable basis. This assistance will support the design completion, survey, and predevelopment objectives for the Mill Creek Restoration at South Skagit Highway Phase 1 Design, PRISM Project #23-1182. Compensation to the County shall not exceed \$75,000. The Agreement shall commence on the date of mutual execution and continue until June 30, 2027.

#### k) RISK MANAGEMENT:

- 27. Participating Group Services Agreement with Caremark PCS Health, LLC for management of Skagit County's pharmacy benefit plan. Compensation is based on a fee schedule. The agreement shall commence on January 1, 2026, and continue through December 31, 2028.
