e) HUMAN RESOURCES:

19. Amendment No. 1 to Personal Services Agreement No. C20230039 with Duncan West to provide support services related to the implementation of Julota. This Amendment extends the term from December 31, 2023 to December 31, 2024. Compensation remains the same and shall not exceed \$100,000 and is based on a rate schedule. All other terms and conditions of the original Agreement shall remain in effect.

g) OFFICE OF JUVENILE COURT:

22. Skagit Detention Center Educational Program Agreement for Educational Instructional Services with Northwest Educational Service District 189. There is no compensation associated with this Agreement. The Agreement is ratified to commence on September 1, 2023 and continue until August 31, 2024.

h) PUBLIC DEFENDER:

- 23. Agreement with the Washington State Office of Public Defense, Agreement No. ICA24030, for the receipt of RCW 10.101.070 funds for the purpose of improving the quality of public defense services in Washington State counties. Compensation to Skagit County shall not exceed \$129,604. The Agreement shall commence on January 1, 2024 and continue until December 31, 2024.
- 24. Personal Services Agreement with Allison Osborne dba Forensic Social Work Services to provide social work services as requested by the Public Defender for clients with adult and juvenile cases. Compensation shall not exceed \$72,000 and is based on an hourly rate schedule. The Agreement shall commence on January 1, 2024 and continue until December 31, 2024.

i) PUBLIC HEALTH:

25. Interagency Grant Agreement with the Washington State Department of Commerce through the Community Development Block Grant (CDBG) Program General Purpose Grant, Contract No. 23-62210-005 for the Skagit County Concrete Community Center Revitalization Project. The major components of the project include upgrades to the kitchen facilities, improving ADA access to bathrooms, adding an ADA accessible shower, improving building energy efficiency and adding a backup power source and will result in increased levels of service. Compensation to Skagit County shall not exceed \$1,235,078. The Agreement is ratified to commence on July 26, 2023 and continue until January 31, 2028.

i) PUBLIC WORKS:

- 26. Personal Services Agreement with Kai Ottesen and Jules Riske, dba Belle Bean Services to provide annual monitoring services to Skagit County's Farmland Legacy Program Conservation Easements. Compensation shall not exceed \$80,000 and is based on an hourly fee. The Agreement shall commence on the date of execution and continue until December 31, 2025.
- 27. Grant Agreement with Washington State Recreation and Conservation Office (RCO) Project No. 23-1181P for

the Martin Slough Fish Passage Design (IL26) Project to design a new crossing on IL26-Martin Slough and will include a high-level alternative analysis on a larger culvert, bridge, or prefabricated/modular bridge should the road become jeopardized. Compensation to Skagit County shall not exceed \$391,000, and Skagit County will contribute \$69,000. The Agreement is ratified to commence on September 14, 2023 and continue until June 30, 2027.

- 28. Personal Services Agreement with Philip Dovinh, U.S. Marine Chemists & Engineering to provide professional services and training classes: Marine Chemist Gas-Free Inspections and Safety Training. Compensation is based on a fee schedule and shall not exceed \$150,000. The Agreement shall commence on January 1, 2024 and continue until December 31, 2026.
- 29. Solid Waste Management Local Solid Waste Financial Assistance Agreement No. SWMLSWFA-2023-SkCoPW-00193 with the State of Washington Department of Ecology (DOE) to provide funding for Moderate Risk Waste Collection, Disposal and Outreach and Waste Reduction/Recycling-Public Education and Outreach. DOE shall provide 75% (\$391,337.50) in grant funding to Skagit County and Skagit County shall contribute 25% (\$130,445.83) for a total amount not to exceed \$521,783.33. The Agreement is ratified to commence on July 1, 2023 and continue until June 30, 2025.
- 30. Personal Services Agreement with Cowling & Company LLC dba Widener & Associates to assist with the completion of the required procedures and documentation for Federal Emergency Management Agency (FEMA) Public Assistance for the November 2022 Storm Event, FEMA2022-4682-DR Projects. Compensation is based on a fee schedule and shall not exceed \$39,215. The Agreement is ratified to commence on April 6, 2023 and continue for an initial term of two (2) years with the option to renew for two (2) additional years.
- 31. Amendment No. 2 to Personal Services Agreement No. C20220180 with Natural Systems Design, Inc. to provide fish passage improvement services for Little Fisher Creek and restoration services for Child's Creek. This Amendment updates the Scope of Work, and extends the term from December 31, 2023 to December 31, 2024. Compensation remains the same and shall not exceed \$100,000. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
- 32. Amendment No. 3 to Grant Agreement No. C20230364 with the Washington State Conservation Commission (2023-25 Biennium Contract No. K2425) to continue implementation of the Voluntary Stewardship Program plan work. This Amendment increases compensation by \$203,787.15 for a new total compensation amount not to exceed \$564,349.65. The term remains the same and shall continue until June 30, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.
- 33. Amendment No. 1 to Personal Services Agreement No. C20200590 with Canyon Environmental Group LLC to support the ongoing monitoring and reporting related to Skagit County's Helmick Wetland Mitigation Site. This Amendment updates the rate schedule and extends the term of the Agreement from December 31, 2023 to December 31, 2024. Compensation remains the same and shall not exceed \$37,500. All other terms and conditions of the original Agreement shall remain in effect.

a) CONSERVATION FUTURES:

1. Memorandum of Understanding for the Land Transfer Navigators Program Supporting Transfer and Access on Agricultural Lands between American Farmland Trust, a District of Columbia nonprofit corporation (ATF) and Skagit County Farmland Legacy (Navigator) to establish a framework for cooperation, collaboration and responsibilities. Compensation to Skagit County shall not exceed \$100,000. The Agreement is ratified to commence on November 1, 2023 and continue until October 31, 2024. The term of the MOU shall automatically renew on an annual basis unless either party provides written notice of termination by October 31 of any year during the then current term of the MOU, provided however that in no event shall this MOU automatically renew after October 31, 2027.
