24. Resolution declaring a sole source purchase for Target Solutions Online Learning Management System for Emergency Medical Services continuing education.

This Amendment extends the term of the Agreement from December 31, 2024 to June 30, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect.

f) HUMAN RESOURCES:

29. Amendment No. 1 to Benefit Specification Form Agreement No. C20240438 with Costco Health Solutions for management of Skagit County's pharmacy benefit plan. This Amendment increases the High-Deductible Health Plan (HDHP) deductible to \$1,650 for individuals and \$3,300 for families to match the 2025 IRS minimums. The Amendment shall commence on the date of execution and continue until terminated. All other terms and conditions of the original Agreement shall remain in effect.

g) INFORMATION SERVICES:

30. Personal Services Agreement with Ednetics Inc. for wireless professional services to configure a pair of C9800 Wireless Controllers and 60 Cisco Wireless Access Points. Compensation shall not exceed \$7,000 including applicable taxes. The Agreement shall commence on the date of execution and continue until December 31, 2026.
31. Agreement with Axon Enterprise, Inc. to provide Axon Evidence Justice Services software subscription services for fifty (50) licenses with unlimited storage to include API access for use by the Prosecuting Attorney's Office with the Karpel Solutions Case Management System. Compensation is based on an annual subscription fee schedule and shall not exceed \$397,320 for the term of the Agreement. h) OFFICE OF JUVENILE COURT:

32. Personal Services Agreement with Volunteers of America Western Washington (VOAWW) to provide Victim Offender Impact Competency Education (VOICE) and conflict resolution classes. Compensation shall not exceed \$7,200 annually for a total compensation amount not to exceed \$21,600. The Agreement shall commence on January 1, 2025 and continue until December 31, 2027.

i) PARKS, RECREATION AND FAIR:

33. Vendor Services Agreement with Concept Construction LLC to reconstruct the remnant trails and bridges, day-use areas, and service roads at Northern State Recreation Area. The trails and service roads were once a part of the trail network on the Farmstead Parcel of the Northern State Recreation Area. Compensation is based on an hourly rate schedule and shall not exceed \$15,000 including applicable sales tax. The Agreement shall commence on the date of execution and continue for one year.

j) PLANNING AND DEVELOPMENT SERVICES:

34. Amendment No. 1 to Vendor Services Agreement No. C20200737 with The Drain Doctor to provide operations and maintenance services for the Edison Subarea Clean Water District. This Amendment updates the scope of work to more accurately fit the needs for the operations and maintenance of the Edison Subarea sewer system with clarifying language and increases compensation by \$169,000 for a new total compensation amount not to exceed \$261,000. The term remains the same and shall continue until December 31, 2025. All other terms and conditions of the original Agreement shall remain in effect.

k) PROSECUTING ATTORNEY:

County Program Agreement with State of Washington Department of Social and Health Services (DSHS), DSHS Contract No. 2463-57750, Division of Child Support (DCS) to update requirements and standards for data security and use of state resources for non DSHS staff. The prosecuting attorney provides Title IV-D child support enforcement services on behalf of DCS and utilizes state resources to do that work. There is no compensation associated with this Agreement. The Agreement is ratified to commence on July 1, 2024 and continue until June 30, 2029.

36. Resolution authorizing Chair Peter Browning to electronically sign the submission of the 2025-2027 Consolidated Contract with the Washington State Department of Health (DOH Contract No. CLH32065).
37. Consolidated Contract with Washington State Department of Health (DOH Contract NO. CLH32065) for the delivery of public health services in Skagit County. Compensation will be outlined in an upcoming Amendment. The Agreement shall commence on January 1, 2025 and continue until December 31, 2027.

39. Interlocal Cooperative Agreement with the Town of La Conner to provide funding for staffing and program supplies for the Senior Services Program. Compensation shall not exceed \$6,966. The Agreement shall commence on January 1, 2025 and continue until December 31, 2025.
40. Interlocal Cooperative Agreement with the Town of Concrete to facilitate a Community Services Program and provide congregate and home-delivered meals to the Concrete community. Compensation to Skagit County shall not exceed \$9,229. The Agreement shall commence on January 1, 2025 and continue until December 31, 2025.
41. Subrecipient Agreement with Catholic Community Services of Western Washington to provide State Opioid Response recovery support services to eligible individuals with opioid use disorders through a grant from the Washington State Health Care Authority (Contract No. C20230029 and Amendment No. A20240249). Compensation shall not exceed \$235,000. The Agreement is ratified to commence on September 30, 2024 and continue until September 29, 2025.

42. Resolution to approve the Guemes Island Ferry Fourteen-Year Capital Improvement Plan 2025-2038.
43. Compensation shall not exceed \$30,000. The Agreement shall commence on January 1, 2025 and continue until December 31, 2025.
47. Personal Services Agreement with AECOM Technical Services, Inc. to provide Guemes Ferry Design Services Support, which includes Ferry System Planning and Facility Design, Marina and Coastal Engineering, and Marine Engineering, on an as-needed, task order basis, for capital projects that are not federally funded. Compensation is based on a rate schedule and shall not exceed \$200,000. The Agreement shall commence on the date of execution and continue for two (2) years.
48. Personal Services Agreement with PND Engineers, Inc. to provide Guemes Ferry Design Services Support, which includes Ferry System Planning and Facility Design, Marina and Coastal Engineering, and Marine Engineering, on an as-needed, task order basis, for capital projects that are not federally funded. Compensation is based on a rate schedule and shall not exceed \$200,000. The Agreement shall commence on the date of execution and continue for two (2) years.

50. Personal Services Agreement with Summit Law Group, PLLC to provide at the request and direction of Skagit County Prosecuting Attorney, Human Resources Director, Deputy Civil Attorney and/or designee, representation and assistance on matters related to labor relations/negotiations and any related litigation. Compensation is based on a rate schedule and shall not exceed \$75,000. The Agreement shall commence on January 1, 2025 and continue until December 31, 2025.

51. Personal Services Agreement with Summit Law Group, PLLC to provide at the request and direction of Skagit County Prosecuting Attorney or designee, Human Resources Director, Chief Deputy or Deputy Attorney or the Risk Manager, representation and assistance on matters related to employment law and litigation. Compensation is based on a rate schedule and shall not exceed \$75,000. The Agreement shall commence on January 1, 2025 and continue until December 31, 2025.

p) SHERIFF:

52. Amendment No. 1 to Personal Services Agreement No. C20230135 with Police Training Solutions to provide, at the request and direction of the Skagit County Sheriff's Office, training and consultation services, management consulting to review current practices, policies and procedures, create a five-year strategic training plan, support services to enhance the County's internal training program and also deliver skill/drill-based training, as requested. This Amendment extends the term of the Agreement from December 31, 2024 to December 31, 2025 and updates compensation which shall not exceed \$30,000 per calendar year and is based on a rate schedule. All other terms and conditions of the original Agreement shall remain in effect.
53. Amendment No. 2 to Interlocal Agreement No. C20210679 with the Town of La Conner for law enforcement services. This Amendment increases compensation for the calendar year 2025 to \$394,035 and will be paid quarterly to the County. The term remains the same and shall continue until December 31, 2026. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect.
