RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS MONDAY, APRIL 10, 2017

The Skagit County Board of Commissioners met in regular session on Monday, April 10, 2017, with Chair Ron Wesen, Commissioner Kenneth A. Dahlstedt, and Commissioner Lisa Janicki present.

I. CALL TO ORDER:

Chair Wesen called the proceedings to order at 10:30 a.m.

II. PLEDGE OF ALLEGIANCE:

Chair Wesen led the gallery in the salute to the flag.

III. AGENDA:

- a) *8:30 a.m. 9:30 a.m. Briefing Commissioners/County Administrator with Planning and Development Services; Public Works; Central Services: Information Services, Geographic Information Services, Records Management; and Emergency Medical Services
- b) 10:30 a.m. 11:00 a.m. Facilities Management Dan Fitting, Director:

Facilities Management Director Dan Fitting provided background information about the building that was under consideration for disposal. Mr. Fitting noted the County purchased the building in 2004. He indicated that the County had no anticipated need for the building and that selling it was part of a larger strategy to consolidate Skagit County facilities.

Mr. Fitting mentioned that the purpose of the public hearing today was to gather testimony from the public and explained the public sale process. He said that if the Commissioners decided to dispose of the building, the sale would be prep by the Treasurer's office through an auction process.

1. Public Hearing: To Consider Testimony Regarding the Intent to Dispose of Skagit County Real Property Located at 45942 Main Street, Concrete, WA

Chair Wesen opened the public hearing at 10:33 a.m.

John Boggs of Concrete said that when the building was purchased in 2004, the intention was for the building to be used as a food bank.

Mayor of the Town of Concrete Jason Miller commented on the lack of notice from the County regarding the intent to dispose of the building and the failing roof and foundation. He urged the County repair the building to bring it up to code.

Angela Massingale of Concrete noted that she was on the Concrete Food Bank Board and spoke about the challenges they faced to find a building to relocate the Food Bank and asked for additional time to find a new location. Ms. Massingale spoke about the possibility of County donating the building to the Food Bank.

Martin Smith of Concrete noted that he was the Coordinator of the Concrete Food Bank and spoke in support of the County allowing for additional time before selling the building.

Seeing no further public testimony forthcoming, Commissioner Dahlstedt made a motion to close the public hearing at 10:48 a.m. Commissioner Janicki seconded the motion. The vote passed unanimously.

Chair Wesen mentioned that the Commissioners would make a decision on the matter in open session on Tuesday, April 11, 2017, at 10:30 a.m., in the Commissioners' Hearing Room.

Chair Wesen recessed the proceedings at 10:50 a.m.

Chair Wesen reconvened the proceedings at 2:32 p.m. and excused Commissioner Janicki from the proceedings.

Senior Civil Deputy Prosecuting Attorney Erik Pedersen noted that the proposed resolution authorized the transfer of the remaining waterworks structure of the Bullerville Sewer District (District) to a bankruptcy proceeding which would allow for the disposal of the last assets of the District.

Mr. Pedersen introduced the Bankruptcy Trustee for Skagit River Resort Andrew and related entities Wilson said that the Resort had been sold and that the sale would closed in approximately three weeks. He indicated that the sale would enable the Resort to pay the State, County debt and pay all of the creditors.

A motion was made by Commissioner Dahlstedt to approve the Resolution authorizing the private sale of the Bullerville Sewer District's assets to the Bankruptcy Trustee as detailed in the Resolution. **(Resolution No. R20170088)** Chair Wesen seconded the motion.

The vote passed unanimously. Commissioner Lisa Janicki's absence was excused

HOME Program Agreement with Home Trust of Skagit to act as the participating jurisdiction under the HOME Investment Partnerships Program which has allocated HOME Funds to Skagit County for Community Housing Development Organizations (CHDO) for Housing Development in furtherance of its goal to increase access to housing for individuals and families who are prepared for homeownership. Total compensation shall not exceed \$100,000 to assist Home Trust of Skagit develop four housing units for Homeownership. The Agreement shall commence on the date of execution and continue until June 30, 2021. (Contract No. C20170182)
- 11. HOME Program Agreement with Home Trust of Skagit to act as the participating jurisdiction under the HOME Investment Partnerships Program which has allocated HOME Funds to Skagit County for Community Housing Development Organizations (CHDO) for Operating Expenses in furtherance of its goal to increase access to housing for individuals and families who are prepared for homeownership. Total compensation shall not exceed \$54,713. The Agreement shall commence on the date of execution and continue until December 1, 2018. (Contract No. C20170183)

f) PUBLIC WORKS:

12. Resolution approving maps, plans, and specifications and calling for bids for Lower Finney Creek Bridge Repairs Project #ES40089-3, Federal Aid #BHS-W290(001). The bid opening is scheduled to take place on Tuesday, May 2, 2017, at 2:45 p.m. or as soon thereafter as possible in the Commissioners Hearing Room. (Resolution No. R20170086)

- 13. Personal Services Agreement with Pacific Surveying & Engineering, Inc. for private consultation and training for Skagit County engineering technicians to use the AutoCAD Civil 3D Software to prepare civil engineering plans. Compensation shall not exceed \$9,255 and is based on a fee schedule. The Agreement shall commence on the date of execution and continue until October 31, 2017 with the option to extend the Agreement by six months. (Contract No. C20170184)
- 14. Permanent Drainage Easement between Skagit County and Michael J. McDaniel and Amanda G. McDaniel for parcels P29670 and P83201 for storm water discharge, drainage lines, drainage structures, culverts, mowing, vegetation management, and other potential drainage infrastructure. The Easement shall be effective on the date of execution. No monetary consideration is being paid. (Contract No. C20170185)
- 15. Permanent Drainage Easement between Skagit County and Donald A. Wetsch and Donna Wetsch for parcel P29640 for storm water discharge, drainage lines, drainage structures, culverts, mowing, vegetation management, and other potential drainage infrastructure. The Easement shall be effective on the date of execution. No monetary consideration is being paid. (Contract No. C20170186)
- 16. Permanent Drainage Easement between Skagit County and Ramon L. Pruiett and Lois E. Pruiett for parcels P29606, P29642 and P29641 for storm water discharge, drainage lines, drainage structures, culverts, mowing, vegetation management, and other potential drainage infrastructure. The Easement shall be effective on the date of execution. No monetary consideration is being paid. (Contract No. C20170187)
- 17. Amendment No. 1 to Local Agency A&E Professional Services Negotiated Hourly Rate Consultant Agreement No. C20160566 with GeoEngineers, Inc. to provide geotechnical engineering for the Cascade River Road Slide Repair Project #ES97950-10. This Amendment updates the Scope of Work and Summary of Costs to remove subconsultant Boretec and adds a new sub-consultant Kingworks Consulting Engineers, PLLC. The new Summary of Costs is reduced and total compensation is reduced from \$42,323 to \$38,092. All other terms and conditions remain the same, including the term which continues until December 31, 2018. (Amendment No. A20170031)
- 18. Vendor Services Agreement with Xylem Dewatering Solutions, dba Goodwin Pumps of America to provide equipment rental for various projects, as described in Exhibit "A". Compensation shall not exceed \$50,000 and is based on a fee schedule. The Agreement shall commence on the date of execution and continue until March 31, 2018. (Contract No. C20170188)
- 19. Resolution authorizing tree topping within Skagit County right-of-way located at 18776 West Big Lake Boulevard, Parcel No. P115907 per Resolution No. 14211. (Resolution No. R20170087)
