#### RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS MONDAY, NOVEMBER 4, 2024

The Skagit County Board of Commissioners met in regular session on Monday, November 4, 2024, with Chair Peter Browning, Commissioner Lisa Janicki, and Commissioner Ron Wesen present.

### I. CALL TO ORDER:

Chair Browning called the proceedings to order at 11:00 a.m. and excused Commissioner Wesen.

#### II. AGENDA:

Chair Browning led the attendees in the salute to the flag.

Robert Knoll of Puget Sound Energy shared comments regarding Puget Sound Energy's transformation and work to strive to meet Washington State's Clean Energy laws. Mr. Knoll thanked the Commissioners for their time and consideration of measures to accomplish shared goals.

- 5. Amendment No. 1 to Standard AIA Form of Agreement No. C20220542 with Allana, Buick and Bers, Inc. for the 4th Floor Demolition and Reroofing on the Skagit County Courthouse. This Amendment expands the scope of services to include additional Construction Phase Consulting Services and Tank Support Framing Design Services. Compensation remains the same and shall not exceed \$362,720. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240221)
- 6. Vendor Services Agreement with Guardian Security, Inc. to provide all labor, demolition, materials, equipment, and supervision for a prevailing wage inspection and maintenance for Skagit County Facilities Fire Protection Systems. Compensation is based on a rate schedule and shall not exceed \$140,000 including applicable taxes. The Agreement shall commence on the date of execution and continue until October 15, 2027. (Contract No. C20240545)
- 7. Amendment No. 1 to Standard AIA Form of Agreement No. C20240082 with Dawson Construction LLC to remove the rooftop jail structure from the courthouse while preserving mechanical spaces and parapet braces prior to reroofing. This Amendment modifies the scope of work and funding for unanticipated requirements during removal of the Courthouse rooftop jail and increases compensation to an amount not to exceed \$2,611,115.63 plus applicable taxes. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240222)
- 8. Amendment No. 1 to Vendor Services Agreement No. C20240176 with Millig, LLC to program HVAC controls towards improving energy performance at the Community Justice Center located at 201 Suzanne Lane in Mount Vernon which does not comply with the State Clean Buildings Program. This Amendment extends the term of the Agreement from December 7, 2024 to December 31, 2025 and decreases compensation from \$175,474 to an amount not to exceed \$174,709.95 including applicable taxes. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240223)
- 9. Amendment A to Grant Agreement No. 22-96663-003, Skagit County Contract No. C20240255, with Washington State Department of Commerce, Local Government Division, through the Community Capital Facilities Unit to provide funding for a legislatively approved project that furthers the goals and objectives of Design and Construction of the Skagit County Crisis Stabilization Center Phase 1 in accordance with 2021-23 Behavioral Health Community Capacity Grants Program appropriated by House Bill 1080. This Amendment updates the UEI#, SWV#, and building address. Compensation to Skagit County remains the same and shall not exceed \$5,800,000. The term remains the same and shall continue until June 30, 2027, contingent on reappropriation; June 30, 2025, if funds are not reappropriated. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240224)

 Resolution to amend Skagit County Personnel Policies and Procedures Manual, Section 3.3.h Compensation During Emergency Events and Incidents. (Resolution No. R20240223)

#### d) INFORMATION SERVICES:

- 11. Professional Services Agreement with Tyler Technologies, Inc. to provide remote server migration services of the Auditor's recording system. Compensation shall not exceed \$4,350. The Agreement shall commence on the date of execution and continue until February 16, 2025. (Contract No. C20240546)
- 12. Amendment No. 2 to Contract No. C20210010 with Granicus to maintain software and hardware for streaming media services which allow the public to watch Commissioner meetings and other public meetings live and via the internet. This Amendment extends the term of the Agreement from December 31, 2024 to December 31, 2025, updates the rate schedule and increases compensation by \$75,169.05 for a new estimated total compensation amount not to exceed \$319,547.90. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect. (Amendment No. A20240225)

### e) PARKS AND RECREATION:

13. Amendment No. 4 to Funding Agreement No. C20170111 with Skagit Land Trust (SLT) to provide reimbursement funding, at the rate of \$90 per hour, in exchange for the SLT providing assistance with the acquisition and permanent protection of lands in Skagit County that will contribute to a corridor for the County's planned Centennial Trail. This Amendment extends the term of the Agreement from December 31, 2024 to December 31, 2026. Compensation remains the same and shall not exceed \$50,000 which is funded through the Special Pathways Fund 102 that is funded directly from gasoline tax revenues. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect. (Amendment No. A20240226)

#### f) PUBLIC HEALTH:

- 14. Personal Services Agreement with Work Opportunities to provide system navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a rate schedule and shall not exceed \$15,000. The Agreement is ratified to commence on August 1, 2024 and continue until July 30, 2025. (Contract No. C20240547)
- 15. Personal Services Agreement with Communities in Schools Whatcom-Skagit for the provision of programming to support low-and-moderate-income families, households that have been disproportionately impacted by COVID-19, and those whose academic achievement or low school attendance signals that they have obstacles that prevent them from succeeding in school. Compensation shall not exceed \$45,434.62. The Agreement is ratified to commence on September 1, 2024 and continue until December 31, 2024. (Contract No. C20240548)
- 16. Personal Services Agreement with Sherwood Community Services to provide navigation services through the Bridges Program to eligible young adults as they prepare to exit their high school transition programs. Compensation is based on a rate schedule and shall not exceed \$20,000. The Agreement is ratified to commence on August 1, 2024 and continue until July 30, 2025. (Contract No. C20240549)
- 17. Amendment No. 1 to Personal Services Agreement No. C20240070 with Tenfold Health to work with Skagit County and the North Star Initiative to strengthen and expand Behavioral Health Recovery Services in Skagit County. This Amendment adds Crisis and Co-Response to the scope of work and increases compensation from \$80,000 to an amount not to exceed \$100,000. The term remains the same and shall continue until December 31, 2024. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240227)
- 18. Amendment No. 1 to Interlocal Cooperative Agreement No. C20240250 with Anacortes Housing Authority to provide funding to conduct predevelopment activities in support of project planning for an affordable housing project located at 212 Commercial Avenue in Anacortes. This Amendment updates Exhibit "A" Deliverables and Services and extends the term from December 31, 2024 to December 31, 2025. Compensation remains the same and shall not exceed \$277,538, which is provided through Real Estate Excise Tax as authorized under RCW 82.46.037. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20240228)

Planning and Development Services Senior Planner Kevin Cricchio provided a PowerPoint presentation and response to the appeal. Mr. Cricchio noted that the staff recommendation was to deny the Appellent's appeal of the Hearing Examiner's denial of Special Use Permit No. PL20-0521, and affirm the Hearing Examiner's decision.

Party of Record Lindy Mullen Doyle provided information regarding violation complaints, noise, fencing, lighting, and exceeding the number of allowable dogs, etc. She reviewed sound reports and nuisance barking complaints.

Party of Record Kevin Doyle shared information regarding nuisance complaints, violations and adverse impacts of the kennel.

Party of Record Val Mullen shared information regarding her opposition to the Special Use Permit application, noise concerns, and living conditions of the animals at the kennel.

Planning and Development Services Senior Planner Kevin Cricchio shared that staff had no further response.

Appellant Alexandra Lemelson provided rebuttal and shared information regarding complaints against her, sound reports, and permitting procedures.

Appellant's Attorney Peter Ojala provided rebuttal regarding application completeness.
