Funding Agreement with City of Mount Vernon for Lincoln Theatre Foundation (Keep Cool Campaign) to award \$20,000 of Lodging Tax funds to support marketing and advertising as authorized by Resolution No. R20240220 and Resolution No. R20240274. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025. (Contract No. C20250078)
- 7. Funding Agreement with The Washington Shakespeare Festival to award \$1,000 of Lodging Tax funds to support marketing and advertising as authorized by Resolution No. R20240220. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025. (Contract No. C20250079)

c) EMERGENCY MEDICAL SERVICES:

- 8. Personal Services Agreement with Cascade Healthcare Services, LLC dba Cascade Training Center to provide training for Advanced Cardiovascular Life Support and Pediatric Advanced Life Support. Compensation is based on a fee schedule and shall not exceed \$147,000 for the entire term of the Agreement. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2030. (Contract No. C20250080)
- 9. Interlocal Cooperative Agreement with Skagit Valley College to provide access to initial Emergency Medical Responder (EMR) and/or Emergency Medical Technician (EMT) certification training to personnel affiliated with licensed EMS provider agencies contracted with Skagit County for the provision of emergency medical services. The County will pay for background checks and course tuition for each student approved for enrollment. Compensation shall not exceed \$400,000 for 2025-2030. The Agreement is ratified to commence on January 1, 2025 and shall continue until December 31, 2030. (Contract No. C20250081)

d) FACILITIES MANAGEMENT:

- 10. Vendor Services Agreement with S&T Window Films, LLC to supply all labor, materials, equipment, and supervision for a prevailing wage project to install glass window film to new storefronts in the Skagit County Elections Department located at 700 South 2nd Street in Mount Vernon. Compensation shall not exceed \$9,131.58 including applicable sales tax. The Agreement shall commence on the date of execution and continue until March 31, 2025. (Contract No. C20250082)
- 11. Amendment No. 2 to Vendor Services Agreement No. C20240115 with Northwest Site Solutions LLC dba Skagit Electric for electrical services for the Skagit County Facilities Management Department. This Amendment increases compensation from \$70,000 to an amount not to exceed \$90,000 and extends the term from March 15, 2025 to March 14, 2026. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect. (Amendment No. A20250020)
- 12. Amendment No. 1 to Personal Services Agreement No. C20220188 with CML Security LLC to provide maintenance of security control electronics including intercom communications, video recording, door operations and management, and control of several utilities in the Community Justice Center Detention Facility located at 201 Suzanne Lane in Mount Vernon. This Amendment increases compensation from \$60,000 to an amount not to exceed \$80,000. The term remains the same and shall continue until July 14, 2025. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20250021)

e) GEOGRAPHIC INFORMATION SERVICES:

13. Interlocal Cooperative Agreement with City of Mount Vernon to establish a cost sharing partnership for Pictometry digital imagery services. Annual compensation to Skagit County shall not exceed \$5,000 plus tax for the

flights, and \$336 per year for seven Pictometry Connect Explorer licenses which may change in 2026 depending on the agency's needs. Total compensation to Skagit County is estimated at an amount not to exceed \$16,643.84 including applicable sales tax. The Agreement shall commence on the date of execution and continue for two (2) years. (Contract No. C20250083)

f) INFORMATION SERVICES:

- 14. Interlocal Cooperative Agreement with City of Burlington to provide Electronic Document Management services. Total compensation to Skagit County is estimated at an amount not to exceed \$25,000. The Agreement shall commence on the date of execution and continue until December 31, 2025. (Contract No. C20250084)
- 15. Resolution to call for bids for Cisco Network Backbone Switch Replacement. The bid opening is scheduled to take place on Monday, March 10, 2025, at 1:00 p.m., or as soon thereafter as possible in the Skagit County Commissioners' Hearing Room located at 1800 Continental Place in Mount Vernon. - 16. Personal Services Agreement with Studio Understory to lead interpretive planning workshops at Northern State Recreation Area. Compensation shall not exceed \$10,000. The Agreement shall commence on the date of execution and continue until December 31, 2026. (Contract No. C20250085)
- 17. Conservation Credit Purchase and Sale Agreement between Puget Sound Partnership (Partnership) and Skagit County (Buyer) for the Swinomish Channel Boat Launch Float Replacement project. The purpose of the Agreement is to provide for the purchase and sale of 38 conservation credits from Puget Sound Partnership for a total cost of \$53,618. The Credit Purchase Form facilitates the process for federal permittees to purchase conservation credits from Puget Sound Partnership to offset Endangered Species Act (ESA) impacts resulting from the maintenance, replacement, expansion, or new construction of structures in the Puget Sound nearshore. The Agreement shall commence on the date of execution and continue until project completion. (Contract No. C20250086)

h) PUBLIC HEALTH:

- 18. Personal Services Agreement with Tenfold Health to support the buildout and implementation of Skagit's North Star Framework and Strategic Pillars. Compensation is based on a reimbursement for services fee schedule and shall not exceed \$450,000. The Agreement is ratified to commence on January 1, 2025 and continue until December 31, 2025. (Contract No. C20250087)
- 19. Rental Agreement with Swinomish Indian Tribal Community dba Swinomish Casino & Lodge for use of the Event Center, set up, takedown, food and beverage service for a North Star summit taking place on June 6, 2025. Compensation shall not exceed \$6,000. The Agreement is ratified to commence on January 17, 2025 and continue until June 7, 2025. (Contract No. C20250088)
- 20. Amendment No. 2 to Professional Services Contract No. K7237, Skagit County Contract No. C20230533 with Washington State Health Care Authority to provide Substance Use Disorder short-term housing subsidies for Recovery Support Services using opioid abatement funds, for people with substance use disorders who are homeless or at risk of being

homeless. This Amendment increases compensation from \$300,000 to an amount not to exceed \$336,433. The term remains the same and shall continue until June 30, 2025. All other terms and conditions of the original Agreement and prior Amendment shall remain in effect. (Amendment No. A20250022)

i) PUBLIC WORKS:

- 21. Resolution to award the bids for the procurement of Maintenance Materials with Annual Purchases Expected to Exceed \$25,000 to the following vendors: Beaver Lake Quarry, McAsphalt Industries, Miles Sand & Gravel, Lakeside Industries Inc., Martin Marietta Materials, Granite Construction, Skagit Aggregates, and Skagit Ready Mix/Smokey Point Concrete. The bid opening was held on January 27, 2025. (Resolution No. R20250028)
- 22. Amendment No. 1 to Construction Contract Agreement No. C20240603 with Olson Environmental for the Nookachamps Creek Riparian Restoration Project #WA120333-1-46. This Amendment increases compensation from \$75,769.99 to an amount not to exceed \$88,801.99 following site visits and contractor review to increase the "common bid amount" of 1-acre to the approved site preparation amount of 17-acres. The term remains the same and shall continue until November 25, 2025. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20250023)
- 23. Amendment No. 1 to Personal Services Agreement No. C20240411 with Natural Systems Design to review and complete engineering designs for replacing an existing multi-barrier culvert on Lower Day Slough. This Amendment updates Exhibit "B" Compensation to include rates of pay, effective August 19, 2024. Total compensation remains the same and shall not exceed \$145,000. The term remains the same and shall continue until December 31, 2025. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20250024)
- 24. Amendment No. 6 to Interlocal Cooperative Agreement No. C20230495 with Skagit Conservation District to allow the County to work with the District on a reimbursable basis for assistance to be provided by the District to the County in meeting Voluntary Stewardship Program (VSP) enhancement goals through implementation of site-specific projects. This Amendment increases compensation from \$384,762.50 to an amount not to exceed \$392,762.50. The term remains the same and shall continue until June 30, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect. (Amendment No. A20250025)
