This Amendment increases compensation by \$37,000 for anticipated services during the 2025 Guemes Ferry haul out. Total compensation shall not exceed \$417,000. The term remains the same and shall continue until April 1, 2025. All other terms and conditions of the original Agreement and prior Amendments shall remain in effect. (Amendment No. A20250046)
- 22. Amendment No. 3 to Personal Services Agreement No. C20240204 with Confluence Environmental Company for the completion of a Skagit Shoreline Needs Assessment in support of the Skagit Marine Resources Committee's (MRC) goal to produce an inventory of prioritized conservation and restoration projects. This Amendment revises Exhibit A, Scope of Work, to add Task 6 to update the nearshore assessment tool to improve the functionality for members, partners, and the public. This Amendment also increases compensation by \$10,000 for a new total compensation amount not to exceed \$50,000. The term remains the same and shall continue until December 31, 2025.
