General Information

The ServSafe Certified Food Protection Manager (CFPM) course and exam helps food business managers understand food sanitation. Most establishments must have at least one CFPM on staff. Upon passing the exam, participants receive a 5-year Food Safety Manager Certificate from the National Restaurant Association and may be eligible for a 5-year Washington Food Worker Card.

The course is currently only available in English. Textbooks and exams are available in several additional languages – please select your preferred language on the registration form.

Course Details

The course is a 4-hour condensed classroom training starting at **8:30 AM**. There will be a break for lunch on your own, followed by a final review session before the exam. The classroom training will cover the following topics and highlight some differences between the exam and the Washington Food Code.

- Who is the Person in Charge (PIC)?
- Demonstration of knowledge by the PIC
- Microbiology basics
- Prevention of foodborne illness
- Hygiene and sanitation practices
- Hazard Analysis Critical Control Point (HACCP) principles
- Time and temperature relationships

Exam

The exam is a timed and multiple-choice. If you are taking the paper exam on a scheduled classroom training day, you may join the review session starting at 1:00 PM even if you are not registered for the course. **Exam check-in will begin at 1:45 and the exam will begin promptly at 2:00 PM** – late arrivals will not be allowed to enter the exam room.

We are also able to offer occasional proctoring for computer-based exams. Please contact us directly for more information.

Course Materials

Course attendees can pick up course materials from Skagit County Public Health after registration. Study the materials and bring them with you.

Exam-only registrations must obtain their own training materials separately. Test booklets and answer sheets will be provided for paper exams.
