- The piece must be brought to the Skagit County Historical Museum by 3:30 on June 1st, 2025, with this form to be in the exhibit and to be considered for the competition.
- The piece must be appropriate for a public audience. SCHM has the right to not display a piece if deemed inappropriate for a public audience.
- 4. Each artist may only submit one work to the competition.
- While we are not requiring a specific size of the piece, please be mindful that we only have so much space in our gallery and that we would like to display as many different works as we can.
- If the artist is under the age of 18, they must provide a guardian that will be responsible for bringing the piece to the museum and picking up the piece at the end of the exhibit.
- While the deadline for submissions and pieces is June 1st, we will only accept submissions until the exhibition space has filled.
- If your piece is digital, please have a physical copy submitted to the Museum by June 1st, 2025.
- If a participant or their guardian fails to pickup their piece by <u>the 7th of</u> <u>December 2025</u>, all remaining pieces <u>will be thrown out</u>.

Conditions Governing This Loan Loan

Loan Period

The loan period is stated on the front of the loan agreement.

Care and Preservation

The Museum will observe the same standard of care for the Property lent under this Agreement as applied by the Museum to any other Property of a like kind in the Museum's care and control. Object handling shall be kept to a minimum at all times during the loan and will be performed only by qualified personnel. In the event of loss or damage, regardless of circumstances, the item on loan will be photographed in detail and the lender will be notified by the Museum immediately by telephone. Any loss from an object must be kept for review by the lender. The Museum will be responsible for the cost of restoring any loan damaged for reasons that may be imputed to the lender while under the loan period. No conservation or repair work, including framing, will be performed without the advance written permission of the lender. The Museum will not loan borrowed items to third parties. It is understood by both the lender and the Museum that all tangible objects are subject to gradual inherent deterioration for which neither party is responsible.

Transportation and Packing

The Lender is responsible for transit costs and for damage or loss to the Property to and from the Museum unless otherwise agreed by the Museum.

The Museum shall advise the Lender without undue delay of any damage, loss or theft. In the event of damage or loss during transit to the Museum, the Museum shall retain all packing and related materials for view by the Lender.

Insurance

The Property shall be insured at the Museum's expense for no less than the total insurable value for the entire period of the loan and until such time as the Property is returned to the care and control of the Lender under an all-risk wall-to-wall policy subject to the following standard exclusions: wear and tear, gradual deterioration or inherent vice; repairing, restoration or retouching processes; hostile or warlike action, insurrection or rebellion; nuclear reaction, nuclear radiation or radioactive contamination.

Publicity and Photography

The Museum shall have the right to make photographs or otherwise copy the Property for publication, educational or publicity purposes connected with the purpose of the Loan. The Museum shall credit the Lender as per the credit line determined by the Lender.

Return and End of Loans

The Museum shall release the Property to the Lender within 10 days after the end of the Loan period herein unless otherwise notified by the Lender in writing. If the Museum is unable to return any items due to an improper address or the unavailability of the Lender, the Museum shall have no further liability for the Property 90 days after the end of the Loan Period, and this Agreement shall be terminated. The Lender acknowledges that the Museum may dispose of the Property in any manner it determines should such termination occur.

The Lender agrees that the Lender shall indemnify and save harmless the Museum, its agents and employees against any charge, cost, claim, demand or expense related to or arising from the Lender's failure to observe the requirements of any state or federal laws or regulations, or from any misrepresentation by the Lender pertaining to the history of the Property.
