    - Still working on where they will be physically working
    - We are getting a Peer Support Specialist case manager
- Kelly Blau VASH
  - Cascade landing has started moving people into the units upstairs
    - Two veterans have moved in so far
  - Still have vouchers with nowhere to place veterans
- Vernon Hunter Vets Connect
  - Working on a 90 day review of subsidies and feedback tracking
    - Vets Connect is working to implement a tracking system to better monitor the progress of veterans
