Guest Speaker

Robby Eckroth, Long Range Planning Manager, Skagit County Planning & Development Services

Robby gave an introduction of himself and his visions with Long Range Planning. He also provided an update from the Planning Commission Meeting on December 12th regarding Agritourism.

- Terry Sapp mentioned having the Ag Board participate in the Comprehensive Plan
- Should there be a sub committee for the Comp Plan, more than Monthly Meetings may be needed to keep updated
- When will Draft Language begin? Summer 2024
- Comp Plan to be completed in 2025
- Have Consultants that will begin working on this as it is a large process- Kimely Horn-Lead Consultants, Cascade for Climate, Transpo working on Transportation, Berk- Rural, Watershed-Critical Areas
- Kick off meeting in January to discuss timeframes and rolls and work out a schedule, then to BoCC with a Scope of Work for approval. February or March for AAB Timeline.
- How can we be sure we get the information needed? Robby will provide frequent updates on the process to the public and boards.
- There will be a web page that will have comments, drafts, and the steps of the process. Listserv to be established for updates as the process progresses.

• Does the AAB have a vision with the Comp Plan and the Agricultural Future. Michael will make a note to discuss at the January meeting.

Planning Commission Meeting Review:

Jack Moore, Director Planning & Development Services

Jack provided an update from the Planning Commission Meeting on December 12th regarding Agritourism.

- Motion to approve the AAB recommendation as presented, there was a second, but it then went into a further discussion.
- Food Production primary goal to protect
- Discussed state level laws regarding protection of Farming
- Growth Management Act types of uses and development where they should be. Many zoning districts in Skagit that may be able to accommodate the non-ag activities
- Worries that the current law and proposal is too strict, maybe needs another pathway. People that have been in business for a while and rely on the income to survive, even if they were not legitimately established to begin with.
- Ag Land is taxed lower, non ag businesses benefiting from that not appropriate
- Split vote- forward a recommendation of adoption the Ag Boards recommendation as it was written 5-2 vote.
- What is next? Jack has reached out to the Commissioners Office to find out the next steps. Schedule a possible work session. Hopefully next month.
- Will comment period happen again at the Commissioner level? Not usually after a public hearing that happens
- Terry attended the meeting, thought it was a very thorough discussion. They did a lot of studying to understand the establishment of code and policy and the comp plan.
- Did not deliberate or discuss any changes or alterations from the AAB Recommendation
- Forward the Meeting Minutes after being signed by the Chair of the Planning Commission
