### Call to Order, Introductions

## Approval of Meetings Summary

Justin Hayton moved to approve the May-June minutes, Nels Lagerlund seconded, motion carried.

## Guest Speaker

### Sarah Stoner, Farmland & Agriculture, Skagit County Public Works

Sarah announced that the Farmland Legacy Program has received a grant from the American Farmland Trust of \$100,000, over the course of four years (2024-2028). She mentioned one of the possibilities

being to subcontract out the money to further the possibilities. While advancing the program, Sarah suggested that the best route to take would be to put together a list of resources, listen to the needs of the community, and get farmers connected with support systems.

- Announced American Farmland grant, that will be used to further the Farmland Legacy Program
- Sarah reported an update of the program that included, surpassing 15,000 acres of agricultural land in Skagit County
- Presented the 2024 Farmland Legacy news article, featuring local farmers

## Jenna Friebel, Executive Director, Skagit County Drainage & Irrigation Districts Consortium

Jenna presented the Skagit County Integration Plan. She proposed forming a natural resource board to accommodate climate change. She suggested setting a meeting up with planners and tribe members.

- Tribal land agreement history
- Pivoting into taking control of natural resources and developing a plan considering; fish and tribal use
- HDM/ERSA connects to advancing program
- Proposed forming a Natural Resources Board
- Climate change; threats and identification
- What threats do we want to address

### Will Honea, Skagit County Prosecuting Attorney

Will had informational additions to Jennas Integration Plan, including the importance of climate change in our County. He spoke about the uses of Riparian Buffers, relating to climate change our streams and wildlife. Will also suggest that a rational approach to climate change that includes the tribes, would be in the best interests of the program and county.

- Planning involving sea level rising, considering dike districts
- The concept that with facts and science, we can prepare for climate change and start adapting our farmlands to that change, now.
- Moving forward, one of the first steps would be for both tribes to come to an agreement

## Don McMoran WSU Update

Don spoke to the board about the updates for WSU that included information about two new interns that have been hired for summer and fall. As well as the grant that was received for Farmer Suicide Prevention.

- Proposed that Sarah reach out to Ag West and Oregon State University, for support.
- Hopeful that the Forestry program will re-open in 2025

- Agriculture and natural recourses are fully staffed again
- Two new interns have been hired
- USDA Farmer suicide prevention grant
