## Guest Speaker

## Rebecca Rising, VSP Coordinator, Skagit County Public Works

Rebecca gave the board an update on the VSP Program (Voluntary Stewardship Program). She explained where the funding has been going and where it is proposed to go in the future. Rebecca also gave the group an overview of the everyday tasks associated with this program.

• The VSP Program was started in 2011, focusing on fish and wildlife and riparian buffers in the county.

- About 1 year ago VSP received 1 million dollars to spend on conservation practices.
- There are multiple programs associated with VSP, including the Water Quality Monitoring Program. This allows us to test and monitor streams in Skagit County to see what lies ahead.

## Will Honea, Skagit County Prosecutors Office Attorney

Will gave the group a presentation about the recent FOSV vs. King County Ruling. Will brought this to the group's attention because of the weakness recently found, in King County's code. This weakness allows "accessory" uses, such as wine tasting on agricultural land.

- The thought is to reflect on this ruling and develop our county's code and possibly a new ordinance.
- The purpose of Agricultural Natural Resource land is to provide land for continued farming activities. Non-agricultural uses are allowed only as accessory uses to the primary use of the land for agricultural purposes. Skagit County Code 14.26.400
- It's important to note that what we allow on ag land now, will affect the future outcomes of farmland in Skagit County.

## Old Business

The board briefly reviewed the 2025 Comprehensive plan, Transportation and Capital Facilities, and found at this time, the plan has little to no impact on agricultural land.
