A. Shoreline variance Application for Ms. Cheryl Bishop, PL07-0806. The proposed project entails demolition of an existing 1132 square foot beach cabin and replacement with a more contemporary 2 story approximately 2500 square foot residence, with a footprint of 1258 square feet. The residence is proposed to be set back 17.5 feet from the OHWM (MHHT) of Samish Bay. The residence and associated appurtenant development will result in an overall site coverage of 35% which is a reduction from the existing 39%. The subject site is located at 11481 Blue Heron Road on the shoreline of Samish Bay, Samish Island, Washington. Preliminary Plat request #PL06-0668 by Ryan Costanti, on behalf of Challenger Ridge Estates LLC, for a Long "CaRD" land division for the creation of twelve (12) single family residential lots, with the remaining acreage placed in an open space designation as a separate lot (Lot # 13) with no residential development right, from a 60 acre original parcel. The proposed residential lots will be located within the Rural Reserve (RRv) zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 24, 2000, and as thereafter amended. Located at 42921, 43095, and 43509 Challenger Road, Concrete, within a portion of Sections 7 & 8, Township 35N, Range 8E W.M., situated within Skagit County, Washington. This pole will be replacing a 33 ft wood PSE utility pole. The utility pole is located within the right of way of Mountain View Road northeast of the hairpin turn. The equipment cabinets will be located below the pole and immediately adjacent to the abandoned gravel pit. The proposed project is located adjacent to 16901 Mountain View Road, Mount Vernon, WA; within a portion of the NW ¼ of Section 36, Township 34 North, Range 04 East, W.M., Skagit County, Wa. D. Special Use Permit PL07-0577 submitted by KDC Architects Engineers, PC behalf of Verizon Wireless filed an application for a Special Use Permit (PL07-0577) for the construction of an unmanned wireless telecommunication facility on an approximate 185 foot self-support tower with space available for a total of 3 cellular carriers within an approximate 45' x 50' leased area. Approximately 1800 square feet of the leased area will

contain the proposed tower and an approximate 11' x 30' equipment shelter for the applicant. An additional 450 square feet of leased area is set aside for future carrier equipment. The top antenna array will have the potential of 12 antennas with 6 antennas being proposed initially. The proposed project is located adjacent to 16713 Mountain View Road, (Big Lake) Mount Vernon, WA; within a portion of the SW ¹/₄ of the SW ¹/₄ Section 25, Township 34 North, Range 04 East, W.M., Skagit County, WA.
