TEAM REGISTRATIONS ONLY

- Team Entry Fee: \$1450.00 (Includes an 11 game guarantee)
 - Due by Friday, December 12th
- Season runs January 10th through March 14th. All games on Saturdays in Skagit County.
 - Seeding Game (January 10th) each team plays a single non-league game to provide feedback for setting up regular season divisions and schedules.
 - Regular Season (January 17th February 28th) each team will play 8 regular season games in 7 weeks.
 - League Tournament (March 7th/14th). All teams qualify for One Day, TWO game minimum league tournament. Teams will be notified on February 13th of their league tournament date.
- Grade Levels & Divisions: Offered in the 3rd- 8th Grades
 - Divisions Grade Levels will be combined as needed (i.e. 3rd/4th, 4th/5th, 3rd-5th, 5th/6th, 7th/8th).
 - Upper/Lower Divisions Teams will choose following Seeding Games on January 8th whether they want to play in an Upper or Lower Division. We will than set and combine grade levels and divisions as necessary to accommodate team requests.
 - Teams and players are allowed to "PLAY UP" in grades/divisions if they have the necessary skill level.
- Rosters: No restrictions on roster sizes, though each player should play in a minimum of four games in order to be eligible to participate in the league tournament. AAU Membership is NOT required for the S.W.I.S.H. League.
- **Uniforms:** All teams are required to wear same color and numbered jerseys (numbers on either front or back).
- Waiver & Concussion Forms All participants must complete and turn in separate waiver & concussion forms with parental consent prior to participating in any practice and/or game.
