The proposed code amendments would not be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection.

Proposed measures to protect such resources or to avoid or reduce impacts are:

Prohibiting the siting of major electrical utilities on Ag-NRL lands.

The proposed code amendments would not be likely to affect land and shoreline use.
