Notice is hereby given that on March 9, 2007, Skagit County will make available on its website the 2006 Critical Areas Ordinance Update Proposal. The documents to be made available are proposed updates to:

- 1. Skagit County Code Title 14, Unified Development Code: Critical Areas Ordinance (Chapter 14.24)
- 2. Skagit County Code Title 14, Unified Development Code: Supporting Chapters 14.04 Definitions, 14.16 Zoning, and 14.18 Land Divisions.

Supporting documentation will include:

- 3. Best Available Science review documents;
- 4. Environmental documents prepared pursuant to State Environmental Policy Act.

This date will also mark the beginning of a 60-day public and agency review and comment period. During this period there will be informational open houses and public hearings before the Planning Commission. After the 60-day comment period ends, on May 7, 2007, the Planning Commission will formulate and forward its recommendations to the Board of County Commissioners for final consideration and possible adoption. The current target date for adoption is July 2007, although this is subject to change.

Following is the schedule for public hearing(s):

1. Tuesday, April 10, 2007: Update amendments to Critical Areas Ordinance and supporting Chapters. This hearing will be continued on Thursday, April 12, 2007 if necessary, to accommodate the number of people wishing to testify.
