 the revised policies and to more clearly differentiate rural commercial
 zones from rural residential zones;
- Amendments to Comprehensive Plan Policy 3C-2.18(b) to eliminate the potential to expand LAMIRDs to include areas developed after July 1, 1990;
- The elimination of Comprehensive Plan Policy 3C-2.2(b) in its entirety;
- Amendments to Comprehensive Plan Policy 3A-2.2 to clearly indicate that resource areas are part of the non-urban area.

September 26, 2008, will also mark the beginning of a 15-day public and agency review and comment period. After the close of the 15-day comment period, the BCC will take final legislative action on the proposed amendments.
