REGARDING THE ADOPTION OF THE
SKAGIT COUNTY ROAD STANDARDS

WHEREAS, good engineering practice calls for the setting of standards for road construction; and

WHEREAS, such standards should be reviewed periodically to insure that they conform to current practices; and

WHEREAS, the public Works Department has reviewed the Road Standards as adopted on June 28, 1983 and all subsequent amendments thereto as adopted by the Board of Skagit County Commissioners, and has identified several revisions for consideration; and,

WHEREAS, the Public Works Department has requested comments from the local development, construction, engineering and surveying community and the general public, and has incorporated those comments as appropriate into the amended Skagit County Road Standards, "Attachment A"; and,

WHEREAS, the Board of Skagit County Commissioners voted to adopt the Skagit County Road Standards, Version 5.2 with the following change to Section 5.03, B, on page 55, remove and replace the first two words of the first paragraph "Regardless of" with "As an alternative to".

NOW THEREFORE, BE IT RESOLVED that the Board of Skagit County Commissioners hereby adopts the amended Skagit County Road Standards, Version 5.2, effective July 17, 2000.
