OVERVIEW

Skagit County is in the process of completing both the Comprehensive Update and Periodic Review of its SMP.

Both the Comprehensive Update and the Periodic Review are required for compliance with the state's Shoreline Management Act.

A very extensive public process for the Comprehensive Update of the SMP occurred previously, and culminated in 2016 with a recommendation by the Planning Commission to approve the proposed SMP with specified changes. However, final adoption of the SMP to complete the Comprehensive Update did not occur.

Despite not completing the Comprehensive Update, the County must now conduct the Periodic Review per the state-mandated timeline. The County will complete both the Comprehensive Update and Periodic Review with the updated SMP.

NEXT STEPS

Responses to comments received during the public comment period will be prepared and presented to the Planning Commission during their deliberations this summer. The Planning Commission will prepare a Recorded Motion, which presents their findings and recommendation to the Board of County Commissioners.

The updated SMP will be adopted by Skagit County, followed by formal review and adoption by Washington State Department of Ecology.

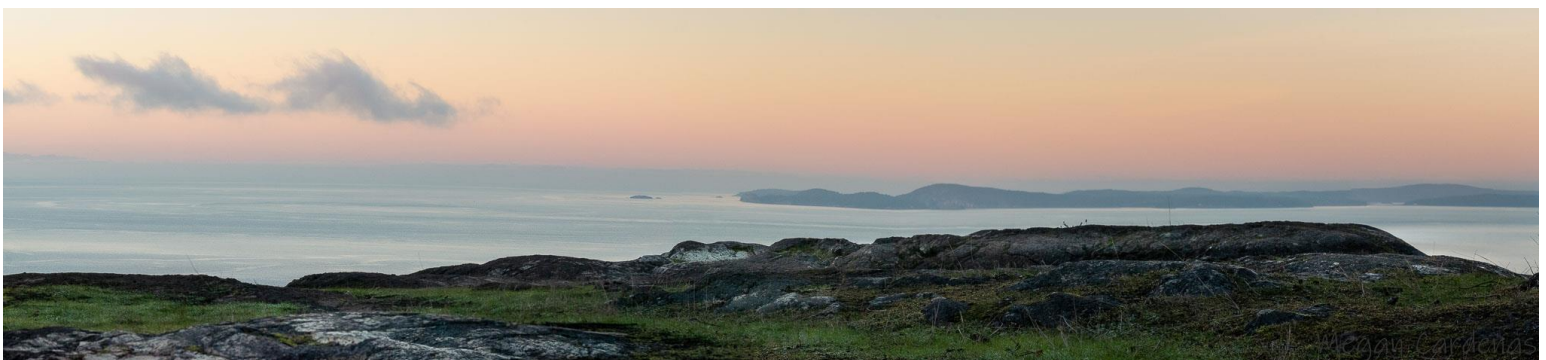
