Agritourism related changes to Skagit County Code Title 14. This includes a new definition for

agritourism and some additions to the definition of agricultural accessory use. Nothing has been proposed to be removed from the definition of agricultural accessory use. Also a reduction in the number of events permitted as an administrative special use for temporary events in AgNRL under SCC 14.16.900(2) (h), this condition to reduce the number of events allowed as part of temporary events use is only applicable to AgNRL and not to other zones. The new definition of agritourism and additional conditions added to accessory to agricultural use, would be applicable to any zone where there is agritourism or accessory uses to agricultural use.

No, this legislative proposal is the only code and policy changes related to agritourism that are proposed.

A non-project legislative action to adopt code changes to Skagit County Code Title 14 that are related to agritourism and agricultural accessory use. These changes include a new code definition for agritourism and additions definition of agricultural accessory Use. Nothing has been removed from the definition of agricultural accessory use, only new conditions have been added.

The proposed definition of agritourism for the code:

A common, farm-based, commercial activity serving the public that promotes agriculture, is directly related to onsite agricultural production, is incidental and subordinate to the working farm operation, and is operated by the owner or operator of the farm or family members. Celebratory gatherings, weddings, parties or similar uses that cause the property to act as an event center or that take place in structures specifically designed for such events are not agritourism.

The proposed additions to the definition of Agricultural Accessory Use are underlined:

- equipment used on-site,
- (6) Miscellaneous agricultural support buildings, including barns, sheds, corrals, farm offices, and coops, which are used for on-site soil-dependent agriculture and which agricultural support buildings shall not be a place of human habitation or place, or be a place used by the public; This permits use of farm buildings for farming. Other uses of buildings would not be permitted and may be permitted only through administrative special use permits.
 - (7) Activities associated with tourism which promote local agriculture; provided, that adequate parking and specified ingress and egress are designated and permitted.
 - (8) Any agricultural or nonagricultural accessory use that is an agritourism event or activity shall be incidental and subordinate to the primary farming operation of the farm site.
 - (9) Any agritourism accessory use must be part of an active farming operation.
 - ~~(7)~~(10) Accessory uses shall be located, designed, and operated so as to not interfere with, and to support the continuation of, the overall agricultural use of the property and neighboring properties.

Additionally, there is a code amendmend proposed for SCC 14.16.900(2) (h) Special Use Permit Requirements to have special conditions for AgNRL which reduce the number of events permitted as part of an administrative special use permit for temporary events. There is also a special condition to events in AgNRL that requires that they be accessory to agricultural use and incidental and subordinate to a working farm.

The new definitions of agritourism and accessory to agricultural use pertain to all zones that have these uses permitted.

This proposal affects all AgNRL land in unincorporated Skagit County and any use that is related to agritourism and or agricultural accessory use in unicorporated Skagit County.

Skagit County's topography includes but is not limited to mountains, valleys and saltwater beaches, AgNRL is part of all this topography (Page 10 of the Skagit County Comprehensive Plan 2016-2036).

The topography of Skagit County ranges from sea level to 8,966-foot Mount Logan (Page 10 of the Skagit County Comprehensive Plan 2016-2036).

Skagit County contains a number of soil series as identified on pages 111 through 115 of the Skagit Comprehensive Plan 2016 to 2036 and referenced pursuant to the Soil Survey of Skagit County Area, Washington, USDA Soil Conservation Service, 1998. AgNRL is classified based on its rich soils that are beneficial for farming.

None proposed as part of the non-project action (legislative proposal).

Skagit County is located in an area traditionally utilized by Southern Coast Salish peoples whose descendants are represented in the present-day by the Upper Skagit, Stillaguamish, Sauk-Suittle Nooksack, Lummi, Samish, and Swinomish Tribes. This is a non-project action (legislative proposal) and therefore does not propose site work.

This is a non-project action (legislative proposal) and would not effect any access to the existing street system.

The County's public transportation needs are served by Skagit Transit (SKAT). This is a non-project action (legislative proposal), it's implementation would not change any access to transit.

- c. How many additional parking spaces would the completed project proposal have? How many would the project or proposal eliminate?**

Parking requirements for development projects are administered pursuant to the requirements

of SCC Chapter 14.16.800: Parking. This is a non-project action (legislative proposal) and would not effect parking requirements. The proposed zoning code change for SCC 14.16.900(2)(h) would reduce annual parking requirements by reducing the number of events permitted with an administrative special use permit in AgNRL.

- d. Will the proposal require any new or improvements to existing roads, streets, pedestrian, bicycle, or state transportation facilities, not including driveways? If so, generally describe (indicate whether public or private).**

Skagit County is required by RCW 36.70A.070 and the planning goals of RCW 36.70.020 to ensure that transportation improvements, transportation systems management strategies, and financial commitments are in place to accommodate the impacts of development. This is a non-project action (legislative proposal) and its implementation will not require any new transportation improvements.

- e. Will the project or proposal use (or occur in the immediate vicinity of) water, rail, or air transportation? If so, generally describe.**

Not applicable. This is a non-project action (legislative proposal).

- f. How many vehicular trips per day would be generated by the completed project or proposal? Not applicable. This is a non-project action (legislative proposal) and this proposed code change reduces the number of temporary events permitted in AgNRL, so would therefore, reduce the number of vehicle trips generated in AgNRL by permitting fewer events in AgNRL.
