NOTICE OF DEVELOPMENT APPLICATION AND SEPA COMMENT PERIOD**

Notice is hereby given that on September 14, 2021, Jeremy McNett, on behalf of Norm Nelson, Inc., filed an independent State Environmental Policy Act (SEPA) checklist (#PL21-0483) for the removal of an existing approximate 5,000 square foot Barn and the construction of a new, approximate, 37,000 square foot unheated and unoccupied potato storage building. The structure will be located on approximately 181 acres in the location of the existing barn to be demolished. The project includes the excavation of approximately 5,000 cubic yards of material for all phases, and the placement of approximately 19,954 cubic yards of material, including pre-load material, for all phases. The project is located within the Agricultural Natural Resource Lands zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016, and as thereafter amended. A letter of completeness was not issued and the application was determined to be complete on September 14, 2021.

The project is located at 15235 Field Road, Bow, within a portion of Section 10, Township 35 N, Range 3 E W.M., situated within Skagit County, Washington. (P34030)

An Environmental Checklist, site plan, and other application materials are on file with Skagit County Planning and Development Services. This information is available to the public on request. Other governmental approvals or permits required for this proposal from Skagit County Planning and Development Services include: Approved Building Grading, and Floodplain Permits.

A decision on the application will be made within 120 days of the date the application was determined complete, which was 9-14-21. A public hearing before the Skagit County Hearing Examiner is not required for this project. Any person desiring to express his or her views or to be notified of the action taken on this application should notify Brandon Black **in writing** of his or her interest within Fifteen (15) days of the date of publication of this notice which is 9-16-21.

Written comments must be received no later than 4:30 pm on: **October 1, 2021**

The Lead Agency expects to issue a DNS for this proposal and the Optional DNS process is being used (WAC 197-11-355). **This may be the only opportunity to comment on the environmental impacts of the proposal.**
