**PROJECT DESCRIPTION:** Notice is hereby given that on September 15, 2017, Skagit County Planning and Development Services approved the independent State Environmental Policy Act (SEPA) checklist review #PL21-0418 for the Fish Creek/Grassmere Road sediment removal/maintenance project. The project proposal includes the removal of 300 cubic yards of accumulated sediment along 325 feet of Fish Creek downstream of the Grassmere Road crossing. The work will begin approximately 250 feet downstream of the crossing on Grassmere Road, at the terminus of the 2017 project. The proposed project is located within the Rural Reserve (RRv) and the Urban Growth Area (UGA) for the Town of Concrete within the Urban Reserve Commercial-Industrial (URC-I) zoning/comprehensive plan designated areas as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016 and as thereafter amended.

**PROPONENT:** Skagit County Public Works, c/o Emily Derenne, 1800 Continental Place, Mount Vernon, WA 98273.

**PROJECT LOCATION:** The site is on Skagit County property between Grassmere Road and the Cascade Trail in the Concrete area, adjacent to 44479 Grassmere Road, Concrete, within a portion of Section 9, Township 35N, Range 8E W.M., situated within Skagit County, Washington. (P43593, P43595, and P43589)

**LEAD AGENCY:** Skagit County Planning and Development Services.

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030 (2)(C). This decision was made after review of a completed environmental checklist, critical areas checklist, and other information on file with the lead agency. This information is available to the public on request.

**The Lead Agency previously issued a comment period for this proposal under the Optional DNS process outlined under WAC 197-11-355.**

You may appeal this threshold determination by addressing those criteria as set forth in Skagit County Code 14.06 and 16.12 and then by filing such with the Skagit County Planning and Development Services for service to the SEPA responsible official within fourteen (14) calendar days after the publication date of this threshold determination.

Appeals must be submitted by: **October 7, 2021.**
