PROJECT DESCRIPTION: Notice is hereby given that on April 25, 2022, Skagit County Planning and Development Services approved the independent State Environmental Policy Act (SEPA) checklist #PL22-0140 for the construction of a new 18,100-gallon metal water reservoir to be located adjacent to the existing 64,400-gallon reservoir. The addition of the new reservoir will return the system to a total storage capacity of 82,500-gallons to maintain the required storage for fire suppression as part of the domestic water system. The project is located within the Secondary and Industrial Natural Resource Lands (SF-NRL and IF-NRL) zoning/comprehensive plan designated areas as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016, and as thereafter amended.

PROJECT LOCATION: The project is located at 24880 Brotherhood Road, Mount Vernon, and the tank will be located on Parcel P18315. The Camp includes 198 acres, on 10 parcels, located east of Lake McMurray and north of State Route 9 within a portion of Sections 29, 30, 31 and 32, Township 33 N, Range 5 East W.M., situated within Skagit County, Washington. (P18315 and P18292)

LEAD AGENCY: Skagit County Planning and Development Services.

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030 (2)(C).
