Proposal Description

Planning and Development Services (PDS) is providing this staff report in advance of the February 22, 2022 Board of County Commissioners virtual public hearing.

According to SCC 14.04.020 an impact fee is "a payment of money imposed by Skagit County on development activity pursuant to this Title as a condition of granting development approval and/or a building permit in order to pay for the public facilities needed to serve new growth and development. Impact fee does not include a reasonable permit fee, an application fee, the administrative fee for collecting and handling impact fees, the cost of reviewing independent fee calculations, or the administrative fee required for an appeal pursuant to SCC 14.30.070." Skagit County has interlocal agreements with jurisdictions throughout the county to collect impact fees on behalf of any district (including for a city or town within their municipal UGAs) only if that district's Capital Facilities Plan is incorporated by reference into the County's Capital Facilities Plan. The County will st op collecting impact fees at the end of the last year of the district's latest Capital Facilities Plan incorporated by reference into the County's Capital Facilities Plan.

Each jurisdiction under an interlocal agreement with Skagit County is responsible for updating its capital facilities plan and impact fee calculations. The following jurisdictions have provided updated CFPs and impact fee rates:

- City of Anacortes
- Sedro-Woolley School District

The updated Capital Facility Plans for the Sedro-Woolley School District and City of Anacortes were included by reference in the Skagit County Capital Facilities Plan (CFP) during the annual update process in 2021. The Skagit County CFP was adopted by the Board of County Commissioners on December 12, 2021.

SEPA Threshold Determination

Skagit County has determined that this proposal does not have a probable significant adverse impact on the environment. An environmental impact statement is not required under the State Environmental Policy Act, RCW 43.21C.030(2)(c). This determination was made after review of a completed environmental checklist and other information on file with the lead agency and is available upon request and at the above listed website.

This determination is issued pursuant to WAC 197-11-340(2). Skagit County will not act on this proposal for at least 14 days from the publish date indicated in the table above. Written comments regarding this Determination of Nonsignificance must be submitted by the written comment deadline (above) and in the same manner as other comments. Pursuant to SCC 16.12.210, no administrative appeal process is available for this legislative action.
