Re: Update on Planning and Land Use Legislation Ordinance

## **PC Comment Draft**

We have drafted new language for the Planning and Land Use Legislation Ordinance based on the Planning Commission's comments at your February 8 meeting and based on comments from the public about specific provisions of the ordinance. We have posted two versions of this document to the Planning Commission webpage at <a href="https://www.skagitcounty.net/planningcommission">www.skagitcounty.net/planningcommission</a>:

- The "February 26 Draft" document shows the new revisions in red and the originally-proposed revisions to current code in purple. Optional text is indicated with brackets.
- The "February 26 Draft Clean Copy" document shows the new revisions in red. Differences between the proposal and current code are not shown.

## **Comparison to Planning Enabling Act**

As you know, Skagit County established its Planning Commission in 1961 using the Planning Enabling Act ("PEA"), RCW Chapter 36.70. As you heard explained by legal counsel at your February 5 meeting, the PEA is one statutory method of organizing a planning commission. The County's proposed Planning and Land Use Legislation Ordinance would reestablish the Planning Commission without using the PEA, relying instead on the state constitutional provisions and GMA, which the County is required to use to plan. See RCW 36.70A.040.

Some recent public comments have characterized the approach of abandoning on the Planning Enabling Act as an "untested theory." It is not. The whereas clauses in the proposed ordinance cite (1) other state planning statutes, (2) code from other jurisdictions, and (3) case law that demonstrates the soundness of this approach. See also the following provisions of the Planning Enabling Act itself, which make clear that using it is just one of many ways that counties can plan:

- RCW 36.70.930 "This chapter shall not repeal, amend, or modify any other law providing for planning methods but shall be deemed an alternative method providing for such purpose."
- RCW 36.70.940 "Any county or counties presently operating under the provisions of chapter 35.63 RCW may elect to operate henceforth under the provisions of this chapter."
- RCW 36.70.547 regarding general aviation airports "This section applies to every county, city, and town, whether operating under chapter 35.63, 35A.63, 36.70, or 36.70A RCW, or under a charter."

At your February 5 meeting, Commissioner Ehlers requested an analysis comparing the provisions of the PEA to the proposed ordinance to ensure that it addresses each relevant provision of the PEA. I've provided the table below demonstrating how PEA sections are addressed in the proposed ordinance. Readers of this document in its electronic form can click the RCW citation to jump to that section on the Legislature's website.

Some sections are not specifically included in the proposed ordinance because they are outdated, addressed by GMA, not relevant to Skagit County, or addressed by other existing county code provisions. As you can see in the table, there are many sections of the PEA that are replaced by the newer GMA (sometimes verbatim), precisely because counties do not have to plan under the PEA.
