It was concluded that the recommended bylaw revisions by Commissioner Henley be revisited at the next meeting after the language can be review by legal counsel

Director Moore discussed the current development projects in Skagit County, including a meeting with the Guemes Island Planning Advisory Committee to discuss regulations regarding saltwater intrusion. Additionally, the Department has been working with Skagit 911 and the Skagit Department of Emergency Management (DEM) to update electronic callout methods and transition work done previously within the Planning Department with FEMA to Skagit DEM
