Summary of Meeting

Approval of Minutes (6/13/2023)

Vice Chair introduced the minutes from the last meeting (6/13/2023) for approval. A motion to approve the June 13th meeting minutes was initiated by Commissioner Knutzen and was seconded by Commissioner Mitchell. The minutes were approved unanimously.

Public Remarks

There were no public remarks.

2023 Docket Applicant Presentations

Kevin Lisser with Lisser and Associates presented on behalf of the Dunlap family for their docket proposal, LR23-01 to rezone the property from Ag-NRL to rural reserve (RRv). Mr. Lisser presented photos of the toe of the slope and the uplands to illustrate that this area is not farmable, and therefore, why they would request a rezone to Rural Reserve. The property is approximately 22 acres, and the rezone would allow for an additional housing unit with a CaRD development. Kevin Lisser answered questions from the Commissioners on why the land was not farmable and whether it could accommodate a barn or other agricultural use.

Heather Rogerson from the Port of Skagit presented on LR23-03, a request from the Port to rezone an acre of property in Bayview Ridge from the existing zoning of Bayview Ridge Residential to Bayview Ridge Light Industrial. She showed pictures to illustrate how it is currently a split zone with six acres zoned Bayview Ridge Light Industrial and one-acre zoned Bayview Ridge Residential. She showed pictures and maps to illustrate that north, west, and south are all light industrial surrounding the property. Ms. Rogerson also showed pictures of a preliminary concept rending of the Port's plans for a business park called Watershed. This proposed development would include a new agricultural innovation campus.

Overview of Comprehensive Plan Update

Long Range Planning Manager, Sarah Ruether presented an overview of the proposed timeline and new legislative requirements that will be part of the upcoming Comprehensive Plan update. The Commissioners asked questions to clarify the purpose and intent of some of the new requirements for the Comprehensive Plan update.
