Approval of Minutes

Public Hearing – 2026 Miscellaneous Title 14 Code Amendments

Public testimony was provided by Terry Sapp and Jan Edelstein. There being no further public testimony, Chair Raschko closed the open record portion of the public hearing at 6:21 p.m.

Work Session – 2026 Docket

Senior Planner Robby Eckroth provided a presentation regarding the 2026 Docket that is being considered by the Board of County Commissioners. Once the docket has been established, the docketed petitions will then be reviewed by the Planning Commission. Mr. Eckroth took questions from the Planning Commission throughout the presentation.

Department Updates

Director Jack Moore gave a reminder that on March 24, 2026, the Planning Commission will be holding a joint meeting with the Board of County Commissioners. Mr. Moore also provided an update on the Board of County Commissions schedule to consider the Agritourism code amendments. Mr. Moore also announced that Planning Commissioner Jed Holmes has resigned from the Planning Commission.

Planning Commissioners thanked staff and those that commented during the public hearing. Commissioner Woodmansee noted that he will be unable to attend the next Planning Commission meeting on March 24, 2026.
