Re: PL12-0258, Anacortes/Tethys UGA Expansion Application Meaningful Public Participation

Dear Commissioners:

Please do not move forward with this petition. It should not be docketed on procedural and legal grounds.

The Framework Agreement, Section 8 states that "GMA obligates each member jurisdiction to include meaningful public participation prior to adoption of any plan or development regulation that may be the subject of any GMA committee recommendation."

The lack of public input into the decisions made by the Mayor of the City of Anacortes, Planning staff and the City Council is clearly evident by the facts. The lack of public participation prior to the GMA Committee/County process has not been contested by the Hovee supplemental. Instead the document contends that the public process will be the responsibility of the County. That is not the intent of Section 8 which is very clear about meaningful public participation prior to any adoption of a GMA Committee recommendation. The Hovee supplemental states that:

"Under the Mayor's administrative authority and on behalf of affected property owners, the City of Anacortes submitted an initial petition to Skagit County for expansion of the City's UGS of July 31, 2012. This action was confirmed by City Council action with opportunity for public comment pursuant to city staff report dated August 9, 2012."

The facts, records of public meetings and staff briefings show there was no meaningful public participation prior to the submission of the petition on July 31, 2012. The following timeline clarifies and illuminates our claim.

July 31, 2012 The City of Anacortes submitted its petition to expand its UGA. The application linked the petition to the Tethys project specifically which was said to be a massive development such that Anacortes and the County have not seen since the building of the oil refineries. No public notice of this action was issued prior to July 31, 2012, nor had City Council discussed or acted on the proposal. The opportunity for meaningful public participation ended at this point.

August 6, 2012 Before the Council Meeting one citizen brought it to the City Council's attention that the petition had been submitted to the County without any notice or hearings.

August 13, 2012 The City Council discussed the UGA expansion during a study session. No public input was allowed as is usual practice.

August 20, 2012 Public comment was permitted on the original petition. Citizens were informed of their opportunity informally at the previous meeting and on the agenda for August 20.

September 4, 2012 City Council discussed a Resolution to process the UGA Expansion

September 24, 2012 The minutes reflect a vague motion passed to proceed with the petition.

The citizens of Anacortes had no meaningful participation in the 'revised petition' contained in the Hovee supplemental on January 23, 2013. On February 19, 2013 during the open comment period one citizen brought to the attention of City Council that the modified application had been submitted without prior hearing or notice and that the petition was no longer 'project specific'.

The revised zone swap, from the Samish property to the Fidalgo Bay LM1 land had only been briefly mentioned in the August 20th meeting when the Ryan Larson showed a map and referenced the site.

Tethys. Again there was no intent to have public input or serious Council discussion of this revised petition.

Appendix G of the Anacortes Comprehensive Plan requires public participation under the GMA Act. It "applies to the adoption of a comprehensive plan, subarea plans, development regulations, and amendments'.

The Rezone of LM1 land to P after County action is a procedural error. Under the current process the citizens of Anacortes would be able to 'have meaningful public participation' only after the UGA petition process has been complete. This essentially means that the public is not intended to be a part of this very public process as required by law. The Rezone of the Fidalgo Area Aquatic Reserve from LM1 to P should be submitted to the process formalized in the Anacortes Comprehensive Plan and Amendment process with all of the requirements addressed in Appendix G.

Mayor/Council Communication and Committee Reports

Mayor Maxwell amounced that at the next city Council study session Council would review the application referenced by Ms. Spargo in her comments. The mayor called it a grand opportunity to replace 15 Jacres that the City lost as part of a purchase and would create jobs for the community.

Mayor Maxwell announced that the Tyler Way right-of-way condemnation ordinance that was continued at the July 16, 2012 meeting had been continued to the regular City Council meeting on September 4, 2012.

Proclamation: Assistance Dog Week: Mayor Maxwell read a statement proclaiming August 5-11, 2012 Assistance Dog Week in Anacortes.

Recognize Mason Cole, AWC Center for Quality Communities Scholarship Recipient: Mayor Maxwell introduced Anacortes student Mason Cole who was awarded a \$1000 scholarship by the Association of Washington Cities Center for Quality Communities. Mr. Cole thanked the community for its abundant support.

Appointments to Board of Adjustment: Mayor Maxwell announced that he would like to appoint Cory Ertel as a permanent member of the Board of Adjustment and William Ballentine as an alternate member. Mr. Geer moved, seconded by Mrs.

City Council Minutes - August 13, 2012

At 7:00 p.m. Mayor Dean Maxwell called the regularly scheduled Anacortes City Council study session of August 13, 2012 to order. City Councilmembers Eric Johnson, Ryan Walters, Erica Pickett, Brad Adams, Bill Turner, Cynthia Richardson and Brian Geer were present.

Council Discussion on Direction to the City Council Planning Committee

Members of the City Council Planning Committee reported on three subjects currently under review by the committee. Mr. Adams reported on the land use matrix being prepared by the committee and staff to show the types of permitted and conditional uses allowed in each zone on one convenient visual aid for use by Council and the public. Mrs. Richardson reported on the committee's review of the packet of suggestions for code changes submitted by former city councilmember Terry Christiansen. Mrs. Richardson said the committee is reviewing the packet item by item and deciding which are not necessary, which deserve to move forward through the regular development regulation amendment process, and which should perhaps be pursued with alterations. She said within the next few months the committee hopes to bring its recommendations on each of Mr. Christiansen's suggestions before the full City Council so it can decide on the next steps, Mrs. Richardson then reported that the committee has also been working on a definition for assisted living based on state code and samples from other jurisdictions. Mr. Adams said the proposed definition will come back to Council as a whole for review and recommendations for further action.

Council Discussion on Urban Growth Boundary Expansion

Planning Director Ryan Larsen reported that staff has been in conversations with Tethys Enterprises regarding the company's continued interest in finding a suitable location for a beverage manufacturing facility in Anacortes but that property of a sultable size has been difficult to locate. He said a portion of the property currently being evaluated is outside the Anacortes Urban Growth Area (UGA) and would need to be incorporated into the UGA to accommodate the Tethys facility. Mr. Larsen reported on the application the City recently filed under the Mayor's Administrative Authority to Skagit County on behalf of several property owners for consideration of an expansion of the Anacortes UGA to include four properties totaling approximately T1-45 acres south of Stevenson Road and west of Reservation Road. Mr. Larsen explained that the Samish Indian Nation recently bought 15 acres of EM1-zoned property in the City's UGA and is in the process of converting that fand to trust status which would eliminate the City's zoning control of that acreage and diminish the amount of land available for industrial uses in the Anacontes UGA below that allocated in the countywide planning policies. He said expanding the UGA as proposed in the recent application and zoning that property LM1 would allow the city to maintain the acreage allocated to it for such uses. Mr. Larsemposed the policy question to Council of whether including this area in the UGA seemed logical.

regardless of whether the Tethysprojecteventually locates there. He said to continue processing the application Skagt County requests a motion and/or resolution from City Council supporting the application. He demonstrated on the aeria photo the notable exclusion of the area in question from the city's UGA when the original boundaries were drawn.

Mr. Larsen suggested that since the present study session was not advertised as an opportunity for public comment, the regular City. Council meeting of August 20, 2012 be advertised to take public comment including comments on a draft resolution that staff will prepare in advance of that meeting. He said Council would not need to take action on the draft resolution at the August 20 meeting and could electionactatthe September 4, 2012 regular meeting instead He added that written comments may be directed to the Planning Director and will be provided to Council. Councilmempers then discussed at length the timetable and course of action proposed by staff. Skagit County deadlines and the opportunities for public participation at the county level if the application is endorsed by City Council and moves on for processing, future Skagit River water flow, the amount of manufacturing land available in the city and its UGA, the odd shape of the current UGA boundary, the timing of and authority for the application filing future Council opportunities to review the Tethys proposal in more detail, whether the UGA expansion would or should occur regardless of the Tethys interest in the site and uncertainties arising from the factithat both Anacortes and Skagit County processes for expanding the UGA are untried at this point Several councilmembers requested additional information on the County process of reviewing the application. Council generally agreed to continuing the discussion following public comment at the August 20, 2012 meeting.

At approximately 7:51 p.m. Mayor Maxwell called a ten-minute break. At approximately 8:00 p.m. the mayor called the meeting back to order.

Council Discussion on Proposed New AMC Title 19, Options A and B - Use of a Hearing Examiner

Mr. Johnson opened the discussion by proposing that the Planning Commission and City Council hold a plenipotentiary session to discuss a potential third option: trying a hearing examiner for three years. Each councilmember discussed the factors leading him or her to favor or disfavor changing to a hearing examiner system. Factors mentioned included Planning Commission work load; the need for development code revisions and proactive planning and the best way to achieve those ends; the relative costs to the City, proponents and appellants of operating under each system; liability and managing same; avoiding ex parte communication in an increasingly electronic age; the success thus far under the current system; responding to public records requests; control of the public record; costs to defend legal challenges to land use decisions and who bears those costs; and ensuring adequate staff support for land use decision makers.

Mayor/Council Communication and Committee Reports

Mayor Maxwell announced that a T loop system has been installed in the City Council chambers so those with enabled hearing aids can use it.

Mayor Maxwell reported that during a recent car fire on SR20 a City of Anacortes sanitation worker, Chris Graham, used his fire extinguisher to help control the fire. The mayor thanked Mr. Graham for responding.

Mrs. Pickett reported on the recent ceremony at Dakota Creek Industries to authenticate the keels of the next two ships to be built at the yard. She mentioned the dignitaries in attendance and described the complicated research ships which are being built for the U.S. Navy but will be operated by the Scripps and Woods Hole oceanographic research institutes. Mrs. Richardson added that a ship currently in for repairs at Dakota Creek, the Thomas G. Thompson, was named after the father of the Tommy Thompson who built the train in Anacortes.

Mr. Adams reported from the Parks and Recreation Committee that N Avenue Park parking improvements are coming soon, Washington Park now has on line campground reservations and a boat launch parking pay machine that takes credit cards, and the Guemes Channel Trail is being worked on by many city departments to make it a reality. Mayor Maxwell added that state legislators viewed the trail when they were in town Friday for a tour and that the city would be asking for an appropriation from the legislature to finish the trail from New York Avenue to Lovric's.

Mr. Turner announced the Traffic Safety Committee meeting the following morning at 9 a.m. and invited citizen comments to him or to city staff.

UNFINISHED BUSINESS

Public Comment: Urban Growth Area (UGA) Boundary Expansion

Mayor Maxwell explained the sign up sheet at the back of the room for those wishing to speak at the meeting, advised that everyone would be given three minutes at the microphone and outlined the procedures for public comment to allow everyone to have a chance to be heard.



Planning Director Ryan Larsen summarized the city's application to Skagit County to add; if 1.15 acres to the city's UGA as discussed in detail at the Study Session on August 13, 20.12. He explained that the parcels in question are currently being evaluated by Jethys Enterprises, Inc. as a possible site for the food and beverage manufacturing facility it wants to locate in Anacortes. Mr. Larsen added that the Samisa Indian Nation recently bought 15 acres of LM1-zoned property in the Anacortes UGA and is in the process of converting that land to trust status which would eliminate the City's zoning control of that acreage and diminish the amount of land available for industrial uses in the Anacortes UGA below that allocated in the countywide planning policies. He then displayed a map showing 31.31 acres of LM1-zoned land north of SR20 in the southern postion of the Edalgo Bay Aquatic Reserve Area that is no longer viable for LM1 use and could be converted to a land use designation that is more environmentally appropriate. Mr. Larsen concluded that staff had prepared a resolution in support of the UGA expansion application for Council discussion and consideration.

Mayor. Maxwell then invited members of the public to speak in the order in which they signed up prior to the meeting.

Stephanie Hamilton, 4412 Glasgow Way, remarked she had just helped move the Boys and Girls Chip to its temporary home in Gry Hall and said it is important to vote to expand the UGA to ensure that there is an inventory of industrial land and jobs for the young people who are our future work force. She said the city's application for UGA expansion makes complete sense and the land in question is literally surrounded by industrial zoned property. Ms. Hamilton said the UGA expansion is not about whether Tethys can locate here it is about allowing property owners to change the zoning of their land to match adjacent properties. She said if Tethys does eventually, locate in the expanded UGA the city will be blessed to grow its manufacturing base and urged proponents of job creation to help make that decision.

Kathy Larson, 8662 Southridge Place, said she moved to Anacortes in 1997 because Anacortes had the best education in Skagit County for her children, education that is supported by two large refineries and other large businesses. She said the UGA expansion proposal seems very appropriate and should have been in the UGA originally. She cautioned against NIMBY's and BANANA said said Anacortes needs family I wing wage jobs. Ms. Larson said she had just toured the Pepsi bottling plant in Tumwater, which provides 400 family wage jobs there and is supported by that community. She urged councilmembers to move the UGA application forward to the county to make that land viable for an Anacortes business.

Peggy Flynn, 2317-18th-Street, urged Council to vote in favor of the UGA expansion. She said the added industrial property will benefit the economic development and economic diversity of the community. She reported that Envision 2060 discovered a dearth of industrial land in Skagit County-only 1800 acres, and that Envision recommended seeking an additional 1600 acres. She said hearly 50% of Skagit

County, residents leave the county to work and that keeping jobs in our community requires increased and Ms. Flynn also commented on the Tethys business plan, saying it calls for a food-grade manufacturing plant using cutting edge technologies. She said the Tethys goal is to create jobs by creating a center of gravity and called it surprising that Anacortes would consider turning its back on the potential for \$000 or more jobs. She unged giving Tethys a chance to perform under its contract with the city.

Alex Taylor, 1907 Cedar Springs Lane, said he read in the Skagit-Valley Herald that the mayor filed this application without consulting Council and asked for clamfication. He said he was glad Council would be well aware of what's going on He urged council to act based on the preferences of the people in the city who elected them. Mayor Maxwell responded to Mr. Taylors request that under his administrative authority the County asked for his signature on the application, which he provided, and now the legislative body is doing its work.

William Harpham, 1403 Portalis Court, said his concern is just who is Tethys. He said Tethys has no desto this area and is a vulture capital firm that wants to develop a property to make a lot of money. Mis Harpham said they want to sell the commons of the people, the river, without any respect to the local citizens. He said if global warming reduces snow pack, there goes the Skagit water flow. He said he is against selling off the commons that belong to the people so Tethys can make a huge amount of money.

Christie Betz, 1612 9th Street said she has numerous worries about the UGA expansion but her major concern was we are on a stippery slope towards allowing a major bottling company to exist and produce in our city. She agreed that we need more jobs but asked why do we want to encourage a business that uses one of our most valuable and important natural resources and makes, sells and deposits into the environment one of the worst ecological products of the 21st century. She urged Council ro deny the UGA expansion and deny Tethys.

Don Wick, Executive Director of the Economic Development Association of Skagit Country (EDASC), spoke in favor of the project. He said Skagit Country has 9.2% unemployment and 47% of the country work force leaves the country daily to work Mr. Wick said EDASC focuses almost exclusively on manufacturing companies because manufacturing has the highest multiplier effect on local economies. He said EDASC had prepared alreasibility study for the Tethys project which he was happy to provide He said manufacturing is central to jobs and a good standard of fiving. Mr. Wick said the GMA stipulates that most population growth should take place in clies so it is incumbent on cities to make sure there is industrial land to service that growth and provide a tax base Mr. Wick said he is very impressed with Tethys and the quality of jobs that will be created, jobs that can't be outsourced. He added that Tethys has always been interested in making sure bottles are biodegradable and using green energy for internal systems.

Jed Gage; 5619 Harrison Avenue; said he spoke; in favor of this not because he believes in abottling plant but because he believes in good long range planning. He said he has been a professional urban planner for lover; 35 years including with the state GMA program Mir Gage; said this expansion makes sense for the simple reason that it provides an option for the future. Whether or not Jethys is, the right occupant for the site; having a chunk of industrial land to convert to a tax generating source of loosits important. Mr. Gage urged Council to support the UCA expansion.

Megikershaw 618-b. Avenue said Councilshould deny the resolution. First she said, the government has confounded and confused the issue of UGA expansion by complementing it with an overlay of a site plan for the proposed Tetrys plant. Second she said the city felt no urgency to mitigate the reduction of the UGA from the Samishiand purchase four years ago is he said this can the hurriedly resolved today.

Andrea Doll 13198th Street addressed the process in owor after the fact. She said city government handles day to day issues without fan fare but other issues are momentous. Withelmus Houppermans, 34.12 K. Avenue said it is not just jobs for the future, that matter but also now council acts in the future. Matt-Miller, 818 Haddon Road referenced his letter supporting the mayors role as chief executive of the water plant to negotiate with potential large water customers and reliterated his support. He called on the elected leaders of the city to act and said that actual industry is required to get our economy and our community back on a steady footing. He asked what would happen, without the good refinery loss that employ Anacotes residents and the financial support the refineries give to schools and community organizations in addition to tax revenue. Here called the bleak economic future in Anacotes before the refineries and urged Council not to close the door on this small step towards a brighter future. He asked council members to woote yes to expandithe UGA as proposed.

Nick Petrish. 1907 9th Street, said Anacortes has always been a working class town and used to stink of salmon canneries and pulp and plywood mills, some of which were worker owned. He recalled his grandfather, stemark that the one thing that stinks the worst is unemployment. He said he is a working class man himself in favor of jobs. He agreed with an earlier speaker that if this thing is going to be built, all of Anacortes should profit from the endeavor, it should be a community business liesaid this is a common, vital resource and he doesn't want a vilture capitalist company controlling Anacortes water. He urged the community to find a way to control its destiny and the profits of this project. He said if that can't be done, the project should not proceed at this time.

Fom Glade, 2.10 Mansfield Gourt, spoke on behalf of Evergreen Islands and the natural environment. He said Anacortes is a small town in a small county and the Tethys plant is huge, oversized for what Anacortes can handle. He displayed a site plan and said the plant footprint is too small for the storage the plant would need so would need more rail siding and the siding would extend out of the EGA into rural martne industrial county land, maybe into rural reserve land. He noted the extension right into the lagoon on Turners Bay that has just been restored, with a sizable salmonize covery grant. Mr. Glade called this a huge environmental impact. He encouraged Council to stop this thing and look for a more suitable thing to go in this location.

loan Cross, 708 South 4th Street, La Copner, spoke of her concerns about the volume of water and length of contract. She asked what happens if glaciers start to dry up in the 50 years of the contract and whether Anacortes would be committed to this contract over and above the other citizens of Skagit County. She asked if La Conner's water prices will go up. She said it will take a lot of infrastructure to move the product out of Anacortes. She inquired again how much will this cost residents of La Conner and other Skagit County citizens.

Arlene French: 1414 8th Street, said she is a Board member for Evergreen Islands and agreed with comments by Tom Glade. Phyllis Dolph and Nick Petrish. Ms French said she appreciates our local industries such as DakotasGreek, the rope company, and Trident, but nonerof these are the largest of their type of plant in the country. She said she has a manufacturing background herself, is a member of the

Chamber, and supports jobs She Said what she objects to is not expanding the UGA. but that it is designed specifically for a company that is inappropriate for our beautiful area.

Rick Haley, 1804 Dear Place agreed Anacortes needs jobs and said UCA expansion in this area may be appropriate but not in this case because it is specifically designed for Techys Mir Haley said bottled water, is an unsustainable practice so before the 50 year contract is up Anacortes will be stuck with a red hering. He riged Council to recall prior testimony on this question and reject the proposal.

Ross-Barnes, 10047th Street, #202, applauded the mayon and Chamber of Commerce for seeking good wage jobs. He said County code requires a UCA expansion application to include a viable, detailed development proposal that is consistent with the applicable designation criteria. He said application item 2c errs when it says the dogleg was an anomaly of the original UGA boundary. He said the original UGA was bounded by Stevenson Road and the spot zone was created later. Dr. Barnes said the current application makes the dog leg worse because it leaves the Turner's Bay western shoreline and the estuary in county jurisdiction He asked if anyone believed the county would allow filling the estuary to build the rail storage and switching yardishown on the Tethys site plan He said the application response to Question 12 is inaccurate. He said the application does not meet contractual requirements for job creation in Anacortesisince the city/county/boundary passes through the middle of the building and their all storage yard will be in the county in incompatible RM and RR zones as well as critical estuarine habitat and within shoreline jurisdiction, Dr. Barnes concluded that the application in no way facilitates on supports the viability and the required detailed development proposal. Knisti Hein, 3100 BlAvenue, saidishe was deeply concerned that citizen objections were being trivialized by councilmembers and said the well researched and thoughtful concerns voiced include water privatization, plastic pollution, wasteful consumption of rossil fuel and its contribution to human-caused climate change transportation bottlenecks, and diversion from other potentially more positive economic development. and he has deep ties in and is committed to the region. He said he shares concerns about the environmental impact of plastic bottles and his view is that business needs to do everything it can to change that equation even if incrementally. He said he is committed to eliminating unrecyclable plastic bottles but still provide products consumers want and provide jobs. He reported the U.S. Bureau of Labor Statistics says beverage manufacturing jobs average \$40K per year. He added that it takes 14 18 jobs per manufacturing line and the planned plant would have 45-60 manufacturing lines so there would be 500 jobs created even before the multiplier effect which predicts 2.4 supporting jobs in the community for each direct job created Mr. Wintersaid Tethys wants to create jobs in alresponsible way and listen to the community. He said it is popular to assume the only motivation is profit and agreed Tethys hopes to make a profit out said neils willing to invest in this community and the region and the environment. He clarified that the minutes are a reflection of actions taken and that all proceedings are recorded and played on Channel 10. He invited Mrs. Elander to meet with him to discuss things that have come across his desk that he felt were inappropriate.

Resolution: Asking Skag it County to Process a Proposed UGA Expansion for the City of Anacortes

Mayor Maxwell opened the discussion by describing the need for blue collar jobs to ensure a sustainable economy and support schools and city services in Anacortes, particularly in the face of state-revenue cuts. He said that annexing this property into the Anacortes tax base is the right thing to do for schools, the community, and workers who are unemployed and underemployed. The mayor said that adding this eleven acres to the Anacortes UGA is appropriate since it is surrounded by light manufacturing in the city's UGA and be encouraged councilmembers to forward the petition to the Skagit Gounty Commissioners and ask them to consider it.

Mr. Geet Mr. Adams and Mr. Turnerspoke inturn that they did not want to terminate discussion of the Tethys proposal and the potential it has for adding jobs to the community. Mr. Turner and Mrs. Pickett addressed citizen concerns about water flow and said Anacortes will have sufficient water now and in the future to homor the terms of the contract with Tethys without placing drinking water or other water customers at risk. Mrs. Pickett urged letting the UGA expansion petition move forward to see how the opportunities unfold

Mass. Richardsom raised a number of questions about what might be proposed to be pullf on this I i acres, how the county process, for UGA expansion works, and how the Samish land figures into the Anacortes UGA allotment. She said that setting aside any discussion of water and Tethys, the city should ask what makes sense in the area insterms of land-use planning. She said the shape of the current area does not make sense and argued that long term the eleven acres, in question should be in the Anacortes UGA allowing the city to decide in the future whether or not to annex it if the right opportunity came along.

Mr. Johnson called for a cost-benefit analysis of the Tethys project. He acknowledged the need for more industrial land in Skagit County and supported expanding the UGA as a step in that direction that would provide continuous pieces of ground someone could actually build on. He suggested more study of the region's future water needs as well as transportation and environmental impacts while Tethys refines its proposal.

Mr. Walters asked Planning Director Ryan Larsen if the Samish Indian Nation had submitted a letter supporting the UGA expansion request. Mr. Larsen said he was not aware of one. Mr. Walters said that under the terms of its contract Tethys has to idenary no later than December 1 which site it wants. He suggested the city wait until Tethys identifies its chosen site and then decide whether or not to pursue, the UGA expansion he said a downside to pursuing UGA expansion now is that the city can only change its UGA boundary once in every seven-year UGA planning period-so this application should include any other heeded boundary changes such as dedesignating unbuildable land currently included in the UGA. Mr. Walters said he also

needed to know more about the Samish Indian Nation's plans for its property since the application assumes that the city will be down zoning the Samish property soon. He said that pursuing the UGA expansion now would diminish the Council's opportunities to impose conditions on the project.

Mrs. Richardson said she appreciated Mr. Geer's remark that not moving the UGA application forward would cut off the discussion about the Tethys project. She did not favor waiting until December 1 but said she wouldn't mind waiting a couple more weeks so some of the questions could be resolved and answered and the application could possibly be slightly modified based on answers to those questions. She said if the UGA can only be adjusted every seven years she dilike to know there's nothing else on the horizon the city would be precluding. She also asked for a more accurate site plan from Tethys.

Mr. Adams said analyzing impact vs. benefit will be a huge part of this project. He said that manufacturing businesses bring benefits to the community including jobs but said knowing how many employees per square foot a business would hire is important because the city only has a limited amount of space. He said he needed that information to make an educated decision and asked again if City Council would have opportunities to condition the project further down the road Mr. Larsen replied that conditions would be established through the EIS process, which is an administrative staff process including public comment.

City Attorney Brad Earlong reminded the Council that there was not currently a development application before the Council so there was nothing to condition. He said if the county were to approve the UGA expansion the city would then have to go through an annexation process, and then amend its Comprehensive Plan to address this piece of property, and then apply development regulations to it, and those regulations would start to set standards for use of the property. After that any development applications would receive environmental review under SEPA and an EIS II a DNS were issued.

Mr. Turner said he was excited at the prospect of having more light manufacturing land in Anacortes, said manufacturing plants provide the most benefits to the community, and called this an opportunity to regain some lost manufacturing zoning which the city needs for the future tax base and jobs.

Mr. Johnson echoed Mrs. Richardson's comment about waiting a couple weeks to avoid unintended consequences involving the Samish land and the seven-year UGA window. He asked to get those questions answered as well as several questions paised by Dr. Barnes in his letter.

Mayor Maxwell cautioned that the Samish may not choose to respond and noted that Anacortes has lost 43 acres of industrial land to estuany habitatise there is plenty of lost acreage to justify the expansion request to the county. He religious

the need to make the community sustainable and develop jobs to pay for basic services. He said he'd like to let Tethys move forward.

Mr. Johnson warned against the city working itself into a box if it is unable to make any more changes to its UGA in the next seven years.

Mr. Geet expressed concern that Council wouldn't have much input on the project specifics at a later stage and asked what the Swinomish think. Mayor Maxwell said he'd spoken with the tribal chairman about it. Mr. Geer said he supported the mayor using his administrative authority to file the application with the county but said it was now up to Gouncil to decide if that direction is appropriate. He asked if Council would have enough more information in 2-3 weeks to make a different decision Mr. Larsen advised that he was meeting with Samish indian Nation in two weeks about how they would like their property rezoned so it would not be a stretch to be able to include that in a few weeks as part of the application.

In response to a question from Mrs. Pickett, Mr. Larsen said that under County code, the city will have another chance to amend its UGA boundary in 2015, when the Comprehensive Plan is updated Mrs. Pickett asked to have a letter to that effect from the county in the file.

In response to a question from Mr. Walters, Mr. Larsen said he did not know what zoning the Samish wanted for their property but said they don't want light manufacturing. Mr. Walters said the UGA allocation is for industrial and commercial land soul the Samish wanted to rezone to something other than commercial that wouldn't affect the city's allocation.

Mr. Turner said postponing the decision any further might cause this business and others to want to locate elsewhere.

Mrs. Richardson moved, seconded by Mr. Johnson, to postpone any decision to the next regular City Council meeting. Mr. Adams, said he would not be able to attend that meeting and asked staff for a timeline showing the hurdles and deadlines to see if there would be any impact to waiting until December 1 to vote on this application. He said he would be at the Council study session on September 24. Mrs. Pickett asked what deadlines there are, Mr. Larsen said the county is waiting for an up or down from City Council so it can forward the application to the County. Commissioners, Mr. Geer asked if waiting three weeks would cause Tethys to miss a deadline, Mr. Larsen said he didn't believesso. Mrs. Richardson amended her motion to bostpone action until September 24, 2012 and Mr. Johnson seconded the amendment. City Council Minutes – September 24, 2012

At 7:00 p.m. Mayor Dean Maxwell called the advertised special Anacortes City Council meeting of September 24, 2012 to order. Roll call found present: Eric Johnson, Ryan Walters, Erica Pickett, Brad Adams, Bill Turner, Cynthia Richardson and Brian Geer.

Resolution: Asking Skagit County to Process a Proposed UGA Expansion for the City of Anacortes

Planning Director Ryan Larsen summarized the history of this item as previously discussed at City Council meetings on August 20, 2012 and September 4, 2012 and presented a draft Resolution 1850 for Council's consideration supporting the continued processing of the Ucban Growth Area expansion application by Skagit County and aslong the County to consider removing Parcel 19696 owned by Robert Separovich from the application. Mr. Larsen reported that at the September 4, 2012 meeting Council requested an outline of the County process for UGA expansion requests and also asked how a delay in adopting the draft resolution would affect the County process for processing the expansion application. He said staff provided answers to those questions in the memo dated September 18, 2012 that was included in the evening's City Council packet. Mr. Larsen reported that at the September 4, 2012 meeting council-requested a revised site plan for the proposed Lethys bottling plant. He said that the plan was received on Friday, September 21 so was provided to councilmembers separately from the other packet materials. Mr. Carsen addressed Council's question about the seven year period for UGA modification. He said Skagit County Code Chapter 14,08,020(5) says that each UGA boundary may be considered for modification once every seven years. The seven year period shall begin the year immediately following the County's completion of its GMA-mandated seven year comprehensive plan update. He said the current seven-year window for UGA boundary modifications runs from 2008-2015. He said the UGA boundary would also be addressed during the 2016 comprehensive plan update.

Public Works Director Fred Buckenmeyer then reviewed some timelines addressed in the City's water agreement with Tethys. Mr. Buckenmeyer said site selection must happen by December 1, 2012-including providing the City, with a legal description and map of the chosen property. He said permit applications must be submitted no more than two years after site selection. Finally, occupancy and use must occur either 24 months from issuance of permits or 42 months from permit application. Mr. Buckenmeyer also remarded that the expiration of the contract does not relieve the City water utility of the duty to serve the development with water pursuant to the Skagit County Goordinated Water System Supply Plan which obliges Anacortes to serve all customers within its designated service area.

Mr. Geer explained his support of the opportunities that could be provided by the LGA expansion and moved, seconded by Mr. Turner, to approve the UGA for further discussion.

Mrs. Richardson and Mr. Johnson each spoke at length to correct misconceptions that had arisen during the public discussion of the project. Mr. Johnson suggested

waiting to approve this application for two more months to put the UGA request in context of the final site chosen by Jethys. Mr. Waiters moved, seconded by Mr. Johnson, to postpone consideration of the motion until December II. City Afterney Brad Ruflong said to take precedence over the motion on the table the motion must be a motion to table and must be to a date certain. Mr. Walters moved, seconded by Mr. Johnson to table until December 1. As a point of order, Mrs. Richardson reminded that that there is no City Council meeting on December 1. Mr. Walters moved, seconded by Mr. Johnson, to table until December 3, 2012. Vote: Aves — Walters, Adams, Johnson, Nays.—Pickett, Turner, Richardson and Geer, Motion failed.

Mr. Turnet spoke to the complexity of the proposed project and the good faith efforts made to date by Fethys. Mrs. Pickett gave examples of current businesses operating successfully in Anacortes that might have seemed too large when first considered. Mr. Geet reiterated the need to plan for industrial expansion to provide lobs for the next eventy years. Mr. Geet called for the question. Motion died for lack of a second.

Mit. Adams spoke to support of manufacturing jobs but said staff had indicated that waiting to consider the resolution until December 1 would not affect the process. He said knowing where Tethys proposed to build would help Council make an educated decision Mr. Walters enumerated additional information needed to make a decision and contrasted the current UGA application with the UGA expansion process underwayin Sedro-Woolley. He urged not voting down the UGA expansion application at the current meeting but reconsidering it after receiving more information Mr. Geer cautioned against sending an anti-business message. Mrs. Richardson and Mr. Turner spoke in favor of allowing the county process to move forward. Mr. Johnson and Mrs. Pickett indicated there would be future opportunities for councilmembers to consider the common good and hear from the public regarding this project. Mr. Walters argued that Gity Council would not have opportunities to condition the proposed fethys project, only to zone the parcel if it were added to the Anacortes UGA.

APPENDIX G

Public Participation Program

PUBLIC PARTICIPATION PROGRAM

This program is adopted under the authority of the Growth Management Act (GMA), RCW 36.70A.140 in order to formalize established practice. It applies only to the adoption of a comprehensive plan, sub-area plans, development regulations, and amendments thereto, adopted under GMA, and does not apply to site specific official applications or projects or the amendment of Countywide Planning Policies. Generally, the policies herein described provide for review by the Planning Commission or the Planning Commission or the Planning

(A) Citizen's Advisory and Technical Advisory Committee input;

Citizen's Advisory Committee (CACs) and Technical Advisory Committees (TACs) have been used by City of Anacortes in the development of the Comprehensive Plan sub-area plans, development regulations and amendments thereto under the GMA. Based upon this experience, the following procedures will be adopted for the formation of CACs and/or TACs:

- (1) A CAC or TAC may be initiated by one of the following methods:
 - (a) The City Council may establish one by resolution; or
 - (b) Any citizen may request the City Council to consider calling for a new CAC or TAC relating to a GMA purpose. The City Council will take public comment on the request. If the City Council is convinced that a new CAC or TAC would be useful, the City Council may authorize its formation by resolution.
 - (c) The City of Anacortes Planning Commission may recommend to the City Council the establishment of a CAC or TAC to participate and assist the Planning Commission and staff in the development of the Comprehensive Plan Elements, sub-area plans, development regulations and amendments thereto.
- (2) If the City Council authorizes the formation of a new CAC or TAC, the City Council will establish a procedure for taking applications and selecting membership to the CAC or TAC, including establishing a term of service and a method of reappointment (if any) for replacement of members. In the formation of a CAC or TAC, the City Council will seek to have a variety of interests represented. A CAC or TAC may be chaired by a member of the Planning Commission to assist the committee in their deliberations and coordinate their efforts with the Planning Commission.
- (3) If a CAC or TAC is recommended as part of a proposed comprehensive plan amendments, the applicant(s) as part of their application shall provide the City Council and Planning Commission with a recommendation for CAC or TAC members, including members from the immediate area or neighborhood (where a sub-area plan is involved). In addition, the applicant(s) shall provide a detailed summary or analysis indicating a proposed timeline to complete the proposed plan or activity, estimated costs, estimated

demands on City staff and resources, a proposed schedule for neighborhood meetings, a plan to disseminate information to affected property owners within the area, how minutes of the meetings will be prepared and documented, and how an accurate record of the committee activities will be maintained for public review. NOTE: these requirements may vary or be expanded depending on the nature of the amendment or activity.

- (4) After formation, the CAC and/or TAC shall follow the requirements in the State Open Public Meetings Act (RCW 42.30). All meetings of the CAC or TAC shall be open to the public and shall be held on a site and times when the working public can attend. The CAC and TAC shall establish and publish a schedule of meeting days, times and locations for committee meetings and shall keep minutes of committee meetings. The City Council may establish by resolution rules of procedure and time frames for recommendations by a CAC or TAC.
- (5) A City of Anacortes Planning Department staff person may be assigned, depending on staffing levels and department activities, to each CAC and TAC to provide staff support and to maintain a copy of the minutes and activities of such committee for public review.
- (6) Notwithstanding these procedures, if the City Council determines that time constraints imposed by orders from the Western Washington Growth Management Hearings Board or other legal requirements likely cannot be met if a CAC or TAC is established and utilized as provided in this section, the City Council need not form the CAC or TAC.
- (7) The Planning Commission may make suggested changes to a CAC or TAC recommendation and either remand it back to the CAC or TAC for further consideration, or forward the CAC or TAC recommendation to the City Council with the Planning Commission's recommended changes.

(b) Public Review, Comment and Hearing Procedures:

- The Planning Commission will review all plans and implementing regulations and then make recommendations to the City Council. The City will follow the procedures in RCW 36.70 and 36.70A, including the right to adopt interim or emergency ordinances if circumstances warrant. The City Council may consider minor on clarifying amendments to plans directly pursuant to RCW 36.70.430-440 or interim ordinances directly. The City Council may set time lines for recommendations by the Planning Commission.
- Proposed drafts of the plans or ordinance(s), together with any SEPA analysis, shall be available for public review when the notice of public hearing is published; this notice shall be published at least fifteen (15) calendar days before the date set for hearing. A staff report or memo, including a description of all documents relied upon, shall also be available at least fifteen (15) calendar days before the public hearing. The public record shall be kept at the Planning Department and shall be available to the public during the hours when that City office is open to the public consistent with the requirements of RCW 42.17.250 et seq. The City will strive to maintain an updated index to the record for each proposed draft of a plan or ordinance. Such index shall be available to the public upon request. Confirmation on the location of the record can be made by contacting the Planning Department. Requests for immediate access to such public record will be accommodated whenever possible, given staffing levels. The requirement for the submittal of information from staff at least fifteen (15) calendar days before the public

hearing, shall not preclude staff from providing new information or a new recommendation based upon additional information which does not constitute a substantial change warranting new public comment. Further, staff may present additional information or analysis in the course of those deliberations to address substantive issues, particularly those raised by public comment or comments or questions from the Planning Commission or City Council.

- (3) Unless adopted as an interim ordinance under the provisions of RCW 36.70A.390, the Planning Commission will hold at least one public hearing at the beginning of its deliberations. Depending on the course of the deliberations, the Planning Commission may hold additional hearings or conduct a neighborhood meeting before making a recommendation, but is not required to do so.
- (4) The Planning Commission will make a recommendation, together with findings, to the City Council unless it is unable to reach a decision on a recommendation. The City Council retains the right, in the event it determines the Planning Commission or CAC or TAC will not return a recommendation in a timely, efficient, and cost effective manner, to terminate the Planning Commission's review and consider the proposal as recommended by the Planning Department.
- (5) The City Council will always hold its own public hearing prior to amending the Comprehensive Plan or Development Regulations, except when establishing a moratorium.
- (6) If, in the opinion of the City Council, the Planning Commission recommendation is substantially different from that which the public last had the opportunity to comment on, or if the City Council determines a substantive change to the recommendation is appropriate, the City Council shall follow the action options found in RCW 36.70, 36.70A, and in addition shall:
 - (a) Allow at least fifteen (15) calendar days for written public comment after notice by one publication in a newspaper of general circulation in the City before taking any final action on the current recommendation, and
 - (b) Provide for at least fifteen (15) calendar days notice of public hearing in the event that another public hearing is to be held.
 - (c) Assure that copies of the proposed recommendation, staff reports, and findings are available at the start of any such public comment period or public hearing notice period.
- (7) The City Council shall not be prohibited from having information sessions on the status of Planning Commission deliberations, nor from providing input regarding the Planning Commission review, as long as any such discussion or input is conducted in public meetings and, if it results in substantial changes to the plan or regulation that had public comment, the procedure for additional comment described above is followed.
- (8) The provisions of RCW 36.70A.390 for interim maps or controls, if applicable to any specific action, would supersede the provisions of this program.

Tom Glade, 210 Mansfield Court, speaking on behalf of Evergreen Islands, quoted RCW 35A.63.070, Comprehensive Plan – Notice and hearing. He then quoted from the City of Anacortes ordinance that adopted the 2011 Water System Plan and incorporated it into the City of Anacortes Comprehensive Plan. He then quoted from the Anacortes City Council minutes of March 5, 2012 reporting Mrs. Richardson's remarks about hearing requirements for the water system plan. Mr. Glade said his land use attorney advised that a hearing was required for the 2011 Water System Plan. Regarding the plan, Mr. Glade asked why the plan includes only 3.4MGD for future industrial use when the Tethys Water Service Agreement specifies the need for 5.5MGD. He also asked why on December 7, 2001 the city voluntarily relinquished 9.7MGD of supplemental water rights. He asked why the public is not being allowed to participate in water planning.

Sandra Spargo, 1408-11th Street, quoted from a February 2, 2013 article in the Skagit Valley Herald regarding the UGA petition which reported comments attributed to Mrs. Richardson Mrs. Spargo said she spoke with the editor and the reporter at the Herald and was told no one had called to make a correction to the quote so they assumed the article was correct. Mrs. Spargo said that neither before acc during the August 20, 2012 City Council meeting did the City Council discuss or generally agree on any Fidaigo Bay aquatic reserve acreage as an UGA petition option. She stated that citizens had no advance information on the 16 57-acres to be rezoned from LML to P including in the packet for that meeting Mrs. Spargo said speaking past citizens weakens the democratic process and public trust.

On Feb. 2, 2103, the Skagit Valley Herald reported on UGA Petition No. CPA-PL-12-0258:

• Richardson said the alternative plan of using the land near Fidalgo Bay instead of signing the 14.47 acres over to the Samish Tribe was discussed by the council and staff in council meetings. She said the council did not officially vote to change the plan from the original application, but the council generally agreed on the use of the Fidalgo land as an alternative. No complaints against the action surfaced through public comment, Richardson said.

I spoke to Colette Weeks, Skagit Valley Herald editor, around 1 p.m. today. She said, "We stand by the reporting until someone calls us and tells us that something was done wrong. We assume that we are correct until someone tells us that we are not." I also spoke to Mark Stayton, the reporter. No one called Mark to ask for a correction of the article, 17 days after publication. No one asked editors Colette Weeks and Beverly Crichfield for an article correction. Therefore, I must assume that Councilwoman Richardson was quoted correctly.

A city council discussion, set by city council precedent, is an exchange of ideas and opinions among city council members at a public meeting within these city chambers that eventually results in an agreement.

However,

- During or previous to the Aug. 20, 2012, city council meeting, the Anacortes
 City Council did not discuss nor generally agree on any Fidalgo Bay
 Aquatic Reserve acreage as an UGA petition option.
- In addition, the City of Anacortes gave its citizens no advance information regarding the 16.57 acres to be rezoned from LM1 to P. The online packet of Aug. 20, 2012, contained no map of the 16.57 acres. On Aug. 20, one minute and four seconds lapsed between the time Mr. Ryan Larsen presented the Fidalgo Bay acreage map and Mayor Maxwell's commencing a public hearing regarding the UGA petition. Shame.

The City of Anacortes sneaks past its citizens, weakening the democratic process and public trust. Going along to get along is not what the people deserve.

Dear Commissioners Dahlstedt, Dillon, and Wesen,

I am writing on behalf of Skagit Audubon Society regarding the request by the City of Anacortes to change its Urban Growth Area (UGA) to include 11.15 acres south of Stevenson Road. Our concerns about this expansion relate to the nearby heronry at March Point and the proximity of the acreage to Turners Bay. We urge you to not support inclusion of this acreage in the city's UGA.

Skagit Audubon Society is the National Audubon Society chapter focused on Skagit County. Our 210 member families support the Audubon mission of conserving and restoring natural ecosystems, focusing on birds, other wildlife and their habitats for the benefit of humanity and the earth's biological diversity. We find that the proposed Urban Growth Area boundary change has the potential to affect wildlife and wildlife habitat to a significant and unacceptable degree.

The bays and other wetlands in the vicinity of the acreage requested for inclusion in the Anacortes UGA are of profound ecological importance. This fact is recognized in Padilla Bay's designation as one of only 28 National Estuarine Reserves in the United States and the sole such reserve in Washington State. Fidalgo Bay, as you know, is one of Washington's just 7 Aquatic Reserves. The importance of these bays due to the species diversity they support is recognized too in the portion of the City of Anacortes's present request which would take 16.57 acres on the southern shore of Fidalgo Bay out of further consideration for industrial or commercial development. Similk Bay is similarly important as is Turners Bay, connecting to Similk and paralleling the 11.15 Rural Reserve acres requested for inclusion in the UGA.

We recall that the Skagit County Hearing Examiner's Findings referenced in Skagit County Commissioners' Resolution Number 18220 dated April 9, 2001, refer to the ecological importance of Turner's Bay. The subject at the time was a planned R.V. campground and equestrian facility west of the bay. Detailed attention was focused then, as it should be now, on the possibility and unacceptability of degradation of the bay.

We note that the proposal under consideration calls for retaining a strip as Rural Reserve along either side of Turners Bay in compliance with the county's Shoreline Master Program. The competitive selection a few years ago of upper Turners Bay for restoration using Salmon Recovery Board funds speaks to the importance of this wetland to salmon and the forage fish on which they feed. Nearly \$700,000 of the public's money was invested here to restore the ecological functioning of the salt marsh and lagoon at the head of the bay. As you know, this pocket estuary was identified as a high priority restoration site in the Skagit Chinook Recovery Plan. We are concerned that the narrow strip of land along Turners Bay which is to remain in Rural Resource under the Anacortes request provides insufficient assurance that this wetland will not again be degraded. Industrial development on the 11.15 acres now in Rural Reserve will generate stormwater and other potential run-off into this bay which will be difficult to control. Development of this and other nearby parcels within the UGA may well lead to re-establishment of the former rail line along the shore of Turners Bay with a resulting increased threat of fuel or other chemical spills or leaks to this recently restored aquatic habitat.

The March Point heronry is one of the outstanding avian features of Skagit County. In fact, as the largest nesting colony of Great Blue Herons around Puget Sound and the Straits and probably the largest in the western U.S., this heronry is of extraordinary significance. The county's Critical Areas Ordinance recognizes Great Blue Heron nest sites as a Habitat of Significance. An aerial view of the heronry location dramatically illustrates its vulnerability, existing in an island of trees surrounded by highways and development. The heronry's presence in such a setting should not fool us into imagining these birds are infinitely tolerant. Washington Department of Fish & Wildlife's March 2012 publication Management Recommendations for Washington's Priority Habitats and Species (Great

~ to conserve and restore natural ecosystems, focusing on birds, other wildlife, and their habitats for the benefit of humanity and the earth's biological diversity ~

Blue Heron; Azerrad, J.M.) notes that, "Great Blue Herons are highly vulnerable to human disturbance, predation, and competition for nesting habitat. Their habit of nesting in large groups makes herons especially susceptible to these types of impacts. A single event involving human disturbance can lead an entire colony to terminate a nesting attempt. ... (E) arly termination of even one breeding attempt can lead to a considerable loss of offspring. This is especially a problem in Puget Sound and the Georgia Basin, where half the breeding population is concentrated into four large colonies." Some large colonies have been abandoned from one year to the next. It is not well known specifically what types of human activities disrupt this species.

Everything wildlife biologists have learned and all that they do not yet know about Great Blue Herons counsels a conservative approach to altering this bird's key habitat, including nest sites, foraging areas (which change seasonally), and staging areas. The cumulative development of industry in the Anacortes UGA and associated activities such as increased rail use, depending on the type of activities and the care with which mitigation is planned and implemented, could eliminate the March Point heronry. This failure of stewardship would not only be an embarrassment to our county and city but more importantly a very significant blow to the population of this protected species. A conservative approach is in order.

The March Point heronry lies approximately two-thirds of a mile from Turners Bay. This is well within the distance Great Blue Herons fly in their daily foraging. It is essential that Similk and Turners Bay, along with Fidalgo and Padilla Bays, retain the ecological integrity needed to support Great Blue Herons, as well as Chinook, Dungeness Crabs, forage fish, and the many other species for which these areas provide essential habitat. Keeping the 11.15 acres in Rural Reserve is the conservative approach needed to help protect Turners Bay for these and other species. We agree with the City of Anacortes' contention that the 16.57 acres along the south shore of Fidalgo Bay should not be developed. The 11.15 acres proximate to Turners Bay should be regarded in the same light. We urge you to reject the boundary change of the Anacortes UGA which would absorb this acreage.

I oppose the Anacortes UGA Expansion Petition. The acreage named for this zoning swap is seriously flawed for this use for many reasons; I ask your consideration of the two most obvious to many concerned citizens.

The populations of Fidalgo Island, Guemes, mid to north Whidbey Island, the San Juan Islanders and the multitude of heavy seasonal/ year round-tourist travelers have only the use of this single route out of the greater area to travel east; accessing further travel north or south. Highway 20 is surrounded on three sides by salt water and the Swinomish Indian Reservation at this carotid artery-like flow for traffic. Both the Duane Berentson Bridge and the Rainbow Bridge would be profoundly affected by any increase of manufacturing truck trailer traffic and any associated rail and support traffic at this locked bottleneck. Serious dangerous backups occur daily now at the turn south at Sharpes Corner on the highway. There is no question added industrial traffic congestion at Reservation Road would produce a dangerous backup pattern that will coalesce. The mega infrastructure of Highway ramps and overpasses and the funding must be considered vitally necessary to any expansion at this area.

East is the only route out. East (or west to Anacortes) through this spot is the route travelled daily for police, fire, emergency medical access, job commute to greater Skagit county, shopping/commerce, personal business, tourism, seat of county government and all the activities of daily life required by our citizens. Let's not be fooled by Anacortes city government believing they don't have enough growth area to work with. This small acreage functions best as rural reserve for the functional ability of the greater region.

Secondly, a map review or personal walk of this area indicates that a majority of the site is either wetland or hydric soils (estuary). An assessment and wetland buffer delineation leaves no room for mitigation. A fish stream runs through the site. What will the impact be for Skagit County regarding the Tribal fish co-op rights and state regulations regarding the Turner Bay salmon estuary? An LMI acreage will involve water runoff and pollutants into Turner Bay and shoreline buffer degredation without question. The standing marsh conditions are legally recognized as a functional part of the existing system. What is the intensity of the proposed use for this area? What kind of jurisdictional conflicts would be created?

As the rest of the Washington State, our nation and indeed the world is responding to science and law demonstrating our need for estuarian functions I do not want to see Skagit County in litigation. This is a hot spot we need prove worthy of our leadership.

I hope to see the docketing of this non-project petition application denied. This is an area to be considered in the 2014 Full Comprehensive Plan Update.


