
















# County Commissioners April 9, 2013 meeting

RE: Proposed Annexation of land to Anacortes City limits

I personally interviewed residents of Reservation Road, Shelter Bay, La Conner, L.C. downtown merchants, and the Swinomish Reservation about this annexation. I talked to, emailed, FB's 100's of people – residents and business owners alike. I talked to 100's of people – I went door to door, shop to shop. I stopped at coffee shops, I went to dances and fundraisers.

With a couple minor exceptions, NO ONE wants this, certainly not the people most affected by it. All political persuasions were against it – whether democrat, republican or independent. In all fairness, I must say I did not go to Anacortes.

Every time we let even the smallest, seemingly insignificant piece of land be turned industrial, we need to look to the future of our valley. The County should be looking at how we can further protect Turner's Bay estuary, the Heron rookery and the wetlands, not annex it into Anacortes.

By chipping away one acre at a time, adding one more train at a time, selling one more gallon of water, we throw away our precious valley and change its character forever.

If it didn't have such unacceptable consequences, this request put forth by the Mayor and Council members of Anacortes, (an obvious "slight of hand") would be laughable. 



A major focus of the study was to differentiate between drainage basins in the annexation area that would require storm water detention and basins where the City could allow an exemption to detention. Unlike most properties in the Fidalgo Basin, all of the annexation properties in the Similk basin were identified as an area where the City might allow detention exemption.

Dear County Commissioners:

Thank you for the opportunity to comment on the proposed 2012 Comprehensive Plan ammendments.

The Washington State Growth Management Act (GMA) requires Counties to create and update Comprehensive Plans, County codes and planning policies that uphold the goals and laws of the GMA. Any Urban Growth Area (UGA) expansion is ultimately decided by the County, not the city proposing the change. The criteria for deciding to approve UGA expansion is required to provide certainty in the 20-year planning timeframe. The GMA discourages piecemeal additions to UGAs which are not a result of changes to the GMA or legal decisions.

The Western WA Growth Management Hearings Board has made many decisions about UGA expansions which guide counties in changing their respective Comprehensive Plans and laws. "One of the fundamental purposes of a Comprehensive Plan is to achieve transformance of local governance within the UGA such that cities are the primary providers of urban services Aberroth v. Skagit County 97-2-0060 (FDO, 9-23-98)". "Continued incremental movement of an UGA boundary that promotes sprawl and inefficient use of tax money did not comply, and also substantially interfered, with the goals of the GMA. Achen v. Clark County 95-2-0067 (RO 11-20-96)".

"The size of any UGA must be based upon the projected population growth allocated to that UGA. 1000 Friends v. Thurston County, WWGMHB Case No. 05-2-0002 (FDO, 7-20-05)". "UGAs cannot be designated or expanded without updated estimates of current and future needs or adoption of methodologies to finance infrastructure. Further a capital facilities plan must reflect the urban facilities and services needed, who will pay for these and provide for concurrency Durland v. San Juan County 00-2-0062c (FDO, 5-7-01)".

The purpose of the UGA review is to determine whether the urban growth areas and the densities within them are appropriately accommodating urban growth. The statute clearly contemplates that the jurisdiction will have a period of up to ten years to measure and evaluate the relative success of the UGA boundaries and densities it has chosen. To conduct that review without a sufficient period of time for evaluation would not allow a meaningful review. Under the analysis proposed by Petitioner, a jurisdiction that, for example, adopted its comprehensive plan in 2002, would have to conduct a review of its urban growth areas immediately thereafter. Such a review would not have a meaningful function since there would be no basis for reviewing the relative success of the

original urban growth boundaries and densities... RCW 36.70A.130(3) allows the County up to ten years from the date of designation of its UGAs to complete its review of UGA boundaries and densities. Wiesen v. Whatcom County, WWGMHB Case No. 06-2-0008 (Order Granting Motion to Dismiss, 7-17-06)".

"The language of the GMA is clear; counties designate UGAs, cities do not. Wells v. Whatcom County 97-2-0030 (MO 11-5-97)". "Without county adoption, city-adopted UGAs extending beyond municipal boundaries have no regulatory effect. Wells v. Whatcom County 97-2-0030 (MO 11-5-97)". The Anacortes UGA Boundary Modification Petition Supplemental Information Submittal, January 23, 2013 prepared for Skagit County by E.D. Hovee & Co., LLC cites the Skagit County Code as the authority for the UGA expansion. The document appears to ignore the fact that it is the GMA that guides and governs UGA expansion decisions. The document cites various other City of Anacortes documents concerning water, sewer, capital facilities and the city comprehensive plan, as well as the County's Transportation plan, but fails to include evidence that under GMA the proposed expansion is permissible.

Historically, the area of proposed UGA expansion has been visited by the WWGMHB. The decision in Anacortes v. Skagit County 00-2-0049c (FDO, 2-6-01) stated: "A CP (comprehensive plan) and DRs (development regulations) must reflect a clear statement that new growth will be encouraged within UGAs. Adding new commercial industrial areas in the rural portion of the county and amendment of a CP to add additional annexation requirements for lands within municipal UGAs does not comply with the Act. Within municipal UGAs annexations must be appropriately planned and must occur." The Rural Marine Industrial Settlement Agreement, executed on June 2, 2003, included the issue of UGA expansion in the same area, and required a number of Skagit County Comprehensive Plan and Code modifications. Friends does not believe that the adjacent RMI property will benefit from the proposed expansion, as suggested by Hovee. In fact the RMI property may well be compromised beyond use should you approve this UGA expansion.

"Under the GMA land is included in an UGA if it is deemed appropriate for urban development. If it is not appropriate for urban development it should be left out of an UGA. Abenroth v. Skagit County 97-2-0060 (FDO, 1-23-98)". Because the City of Anacortes has not met the requirements under GMA to warrant the adoption of the proposed UGA expansion at this time, we urge you to deny the proposed UGA expansion.

#### Commissioners:

I write to express objections to the Anacortes (CoA) proposal for the UGA expansion. While I understand that you are reviewing the proposal without consideration of the project for which the change is proposed, I offer the following observations:

- There are serious environmental issues in the CoA proposal that have been adequately addressed by others. I urge you to take the high ground and make your decision based on such concerns. It should be obvious by now that we cannot afford to make decisions in which so-called economic-development proposals are pitted against significant environmental and quality-of-life considerations.
- It is my understanding that in recent months commitments have been made among various governmental entities in Skagit County to work more cooperatively. Within such agreements, no entity should be allowed to change boundaries without serious review by others. Between the Port and the City of Anacortes alone—to say nothing of other entities in the county--there is ample commercial potential to address the anxiety about future revenues--given a little imagination.
- While you may not want to review the specific project for which the proposal is being made, the County might want to consider the impact of any proposal in terms of rail traffic alone, given the range of projects being considered. Rail traffic along Highway 20 is increasing with refinery activity and more is proposed. Added east-west traffic, coupled with a potential for north-south coal train activity, could be devastating to both environmental and human communities.
- As a county committed to preserving farmland, all development should be reviewed for potential impact on that commitment. Much has been made about the adequacy of the Skagit River and the CoA ability to provide water, especially in statements that the "average annual flow" of the river is adequate. I question the accuracy of that statement, but at best it fails to recognize that seasonal fluctuations impact agriculture and Anacortes does implement water restrictions.
- Finally, by separating the proposal from the project, consider the potential for unintended consequences. For example, while a member of the South Fidalgo Community Council, we reviewed a county drainage study in which the consultant noted the purpose of moving water off the island as quickly as possible. When asked about the potential impact on aquifer recharge areas, the consultant also noted that it was not in the scope of review. Enough said.

It is widely accepted now that "the bottom line' is more than economics—it equally includes the economy, environment and quality of community life. The City of Anacortes has yet to make a believable case for even the economics of its proposal. The City was perhaps shrewd early-on in water matters, but recent activities have a proprietary--if not an imperialistic--odor. Please do not let that happen to the rural character of this island.

My name is Janet Casey. I have been a resident of Skagit County for 33 years. For 30 of these years I owned a retail business in La Conner. I traveled Reservation Road five days a week past the proposed 11.5 acres of land which is now being considered for the Anacortes UGA expansion. Reservation Road is a vital link for the residents of Shelter Bay and La Conner for medical, emergency and retail services in Anacortes. Delays or obstruction caused by trains or trucks associated with major industrial operations will have life and death consequences. Additionally, retail and restaurant business will no doubt be significantly affected, as La Conner residents are forced to Burlington and Mt. Vernon instead of Anacortes. Although not easily quantified, the negative financial impact on visitors from Whidbey Island, Fidalgo Island, the San Juans and Canada who choose to bypass La Conner due to limited access could be great. This may seem insignificant to people who are guaranteed a paycheck but this one factor of impeding or diverting traffic that can mean the difference between a merchant remaining viable, having employees, or eking out an income in this already fragile economy. Of course, every dollar not spent in each municipality translates to a loss in its tax base. For Anacortes, this may seem like collateral damage for what it gains by building a large plant or selling municipal water. For the City of La Conner, this could be a significant portion of their revenue.

However, these considerations are MINOR compared to the negative, potentially significant (and irreversible) environmental impact that could result from allowing industrial manufacturing on this acreage bisected by train tracks and contiguous to a salmon recovery estuary.

I am aware that the January 23, 2013 supplemental UGA annexation petition states that the petition "is not specific to any individual potential user", but I find it incredible (that is not believable) that a potential user has not been identified. There is ample evidence in newspapers, comments by corporate CEO Steve Winter, and in documentation in county records that a user has been identified and is inexorably linked to this petition. In fact, Tethy's needs this UGA expansion as an integral part its forty plus acre industrial park. Two examples follow: 1) The consulting firm E.D. Hovee prepared a 47 page document for Skagit County Planning Department to address questions in the original UGA. This response was paid for with \$20,000 in loans from the City of Anacortes to Tethy's Enterprises. 2) County permits show that on 7/25/12 the applicant for lot certification for all 6 parcels in the UGA expansion area was Tethy's Enterprises.

Therefore, I maintain it is totally appropriate to use a plastic water bottling plant as an EXAMPLE OF A POTENTIAL light manufacturing industry that MIGHT buy and utilize this UGA area. If so, I submit photos of what potentially could occur if a train carrying plastic nurdles, used to manufacture the bottles had an accident. How would the spill into the fragile Turner Bay estuary be contained? What would this contamination do to the wildlife that might injest these particles?

What is the impact on Skagit County's air quality if the manufacture of these bottles releases carcinogenic chemicals such as benzine?


This is one huge Pandora's box that you are asking the citizens of Skagit County to buy gift wrapped and unopened. I implore you to reject the docketing of this non-specific application. Do your jobs to protect the inhabitants of Skagit County now and in the future. Require that a UGA application be re-submitted that is an honest representation of the specific project that we all know is planned.

In closing, the non-profit organization, The Great Wild Salmon Run, dedicated to "protect, restore, educate, and support" the salmon, quotes Ansel Adams in their web-site: "It is horrifying that we have to fight our government to save the environment." Please do not let this be the case in the county we love. Please do not "pave paradise and put up a parking lot."

I respectfully urge you to reject this nonspecific UGA expansion application and require that a revised application should be submitted as project- specific modification.
