Skagitonians to Preserve Farmland supports the continuation of the moratorium on permit applications for certain uses and activities on Agricultural Lands.

Farmers today face increasingly difficult challenges—from unpredictable weather and wildlife impacts to supply issues, price volatility, marketing hurdles, and water scarcity—all compounded by a deeply uncertain regulatory environment.

Uses that fall outside the bounds of farming and do not directly support a working farm can, through their size, scale, or frequency, make it harder to sustain agriculture in the Ag-NRL. Simply put, farmland is for farming.

We commend the county for its ongoing efforts to clarify and update the code in ways that reduce conflicts and align with the guiding principles in the Comprehensive Plan: to "Preserve agricultural land for agricultural uses" and to "Limit new non-agricultural uses and activities on Agricultural Resource Lands" (Source: Skagit County Comprehensive Plan, page 104).

We are, however, concerned about the current Voluntary Compliance Agreement (VCA) process. While Skagitonians to Preserve Farmland recognizes that people's livelihoods are at stake and appreciates the county's efforts to find a path to compliance for existing operators whose activities are not permitted in the Ag-NRL, it is troubling that this process could allow those non-compliant activities to continue under new ownership, indefinitely. This undermines the county's own arguments in the draft resolution to extend the moratorium, below (emphasis added by Skagitonians to Preserve Farmland).

An Interim Ordinance Declaring an Emergency and Adopting a Moratorium on the Acceptance of Permit Applications for Certain Uses and Activities On Agricultural (Ag-NRL) Lands

WHEREAS Skagit County's prime agricultural soil is a critical and irreplaceable natural resource that we are duty-bound to protect for future generations, and <u>protecting the Skagit for commercially viable agriculture is squarely in the public interest</u>; and

WHEREAS Skagit County has consistently declared that <u>development unrelated to agriculture is to be discouraged on</u> designated Agricultural Natural Resource Lands (Ag-NRL); and

Given the county's ongoing efforts to establish clear restrictions on temporary events in the Ag-NRL and to define agritourism, it's important to recognize that these forthcoming regulations will apply to farmers who have followed the rules from the beginning.

We urge the county to address the following critical questions:

- What safeguards will be in place to prevent grandfathered operations from expanding the size, scale, or frequency of previously non-compliant activities?
- What oversight and enforcement mechanisms will the county implement to ensure ongoing compliance with land use regulations?

As the county moves forward, it must ensure that its policies support the long-term viability of agriculture in the Ag-NRL. We urge the county to continue working to remove unnecessary obstacles to farming and reinforce the principle at the heart of this issue: farmland is for farming.

We appreciate the county's work on these complex issues and its willingness to thoughtfully consider public input as part of this important process.
