



3. For each separate proposal, the total price to Skagit County must be shown. No adjustments, credits, rebates, or other charges by the bidder will be considered after the bid opening. All bidders must be able to sell all products, no partial proposals will be accepted.

The Board of County Commissioners will award the bid to the lowest or best bid, from a responsible bidder, taking into consideration: price, warranties offered, and other factors that will contribute toward their exercising judgment to obtain the best value for the County. **Bidders must prove they are an F5 Certified Reseller and that they have been in business selling the specified hardware for a minimum of 5 years.** The Board reserves the right to waive minor irregularities in the bidding.
