Then on April 30 and October 31, or the next business day should these dates fall on a weekend, your tax payment will be made automatically for the amount shown on your tax payment coupon(s). If you choose to pay the full year, this will be withdrawn on April 30. If you have already signed up for Autopay please disregard this form, or use it to update your information, if necessary.

<u>Property tax accounts that are paid by mortgage company escrow accounts are NOT qualified for enrollment in Autopay. Please verify your lender does not pay your property taxes before submitting this form to our office.</u>
