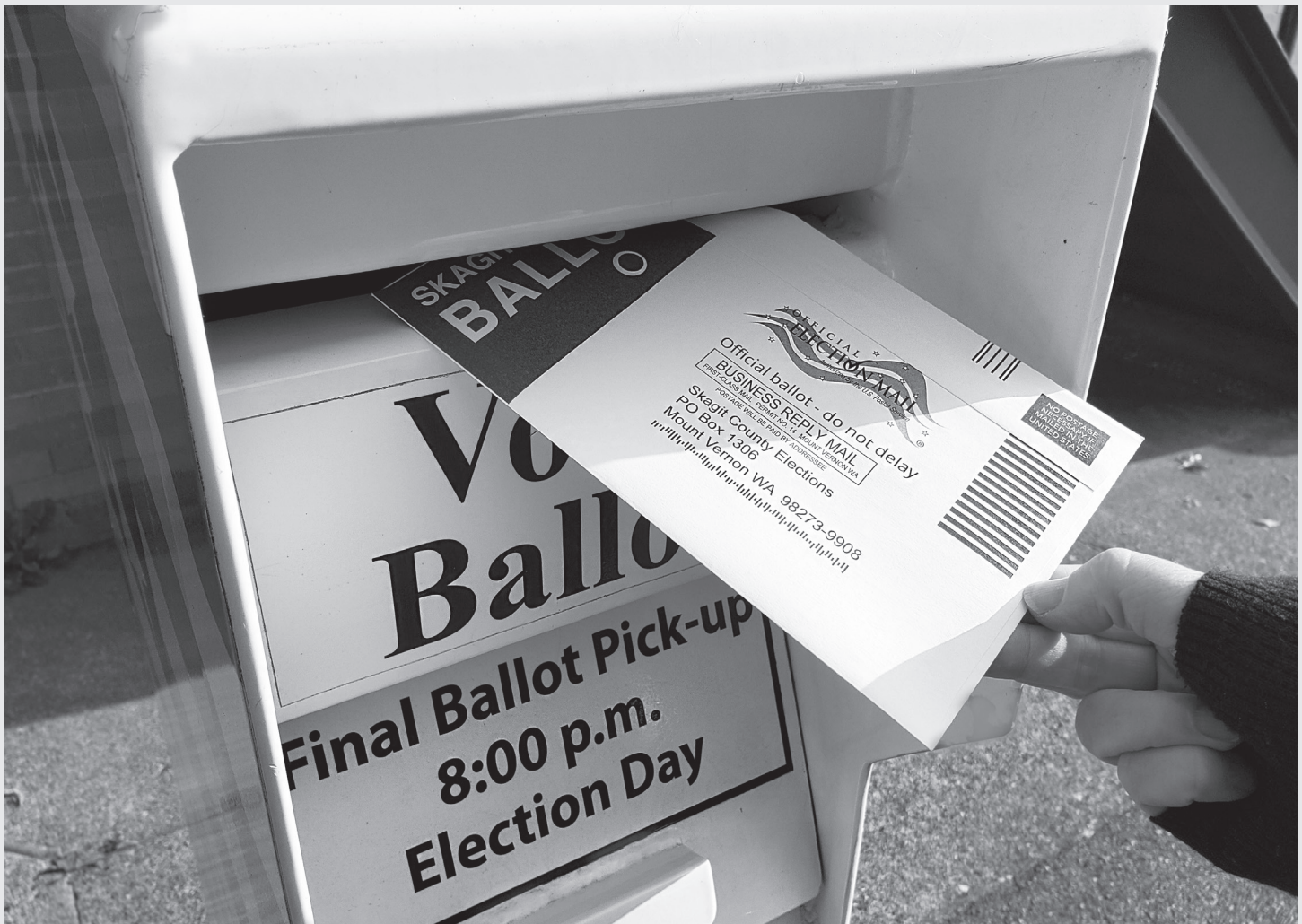

Dear Skagit County Voters,

Your vote is your voice! That's why having information about candidates is important. We hope this printed pamphlet is helpful in making your voting decisions. This election, candidates will be running for federal, state, and county positions.

As a voter, here are ways to ensure that your ballot is counted:

- Return your voted ballot quickly
- Use a ballot drop box whenever possible
- If you return your ballot via US Postal Service, make sure it is postmarked by Primary Election Day, August 4, 2026
- Sign your return ballot envelope
- If you receive a letter from our office regarding your signature, return it to our office as soon as possible.

The sooner voters return their ballots, the more complete the results will be when we post them on election night!

The following instructions are also found on your ballot and the ballot wrap.

## Instructions

### Vote for one in each contest

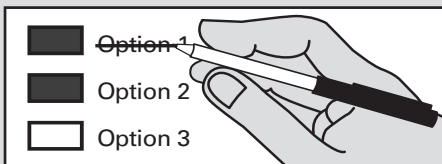


Fill in the box to the left of your choice using black or blue ink.

You may leave a contest blank; your ballot will still count.

If you vote for more than one, no votes will be counted for that race.

### Correcting a mistake



Draw a line through the incorrect candidate name or ballot. You may then you may make another choice.

### Optional write-in

To vote for a candidate not listed in that contest, fill in the box to the left of the dashed line and print the name on the line.

### Vote your ballot...

Use a blue or black ink pen to mark your ballot.

You may leave a contest blank, your ballot will still count.

Put your voted ballot in the security sleeve.

Put the security sleeve in the return envelope.

Seal the return envelope.

Sign and date the declaration on the return envelope. If you are unable to sign, make your mark and have it witnessed by TWO people. *Ensure that both people sign the envelope.*

A power of attorney cannot be used to sign a ballot.

### Place your ballot in a ballot drop box ...

Deposit your ballot in a drop box. Drop boxes are picked up by Elections department staff, not the USPS. See drop box locations on the next page.

Drop boxes open 20 days before Election Day. They remain open 24 hours a day until 8:00 PM Election Night.

Skagit County Elections strongly encourages using drop boxes.

### Or return your ballot by mail...

**NO STAMP** required if mailed in the U.S.

*Ballots sent by mail **MUST** be postmarked no later than Election Day*

*USPS recommends mailing your ballot at least 7 days before election day*

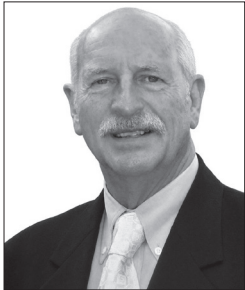

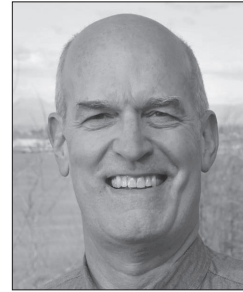

The Board of Directors of Darrington School District No. 330 adopted Resolution No. 453-04-26, concerning a proposition for a replacement levy for education. This proposition would authorize the District to levy the following excess taxes, replacing an expiring levy, on all taxable property within the District, for educational programs and operations expenses not funded by the State, including reduced class sizes, counselors, arts, athletics, music, extracurricular activities:

**Explanatory Statement**

Written by Darrington School District No. 330

Passage of Proposition No. 1 would allow the Darrington School District to replace an existing educational programs and operations levy that will expire at the end of 2026. The replacement levy will be used to pay expenses of educational programs and operations that are not fully funded by the State of Washington, including: reduced class sizes, school nurse, mental health specialists, school counselors, arts, athletics, music, extracurricular activities, teaching, student support, textbooks and classroom supplies, student transportation, professional development and training, and other school operations. The proposed four-year replacement levy would authorize collection of taxes to provide up to \$950,000 in each of the years 2027 through 2030. The levy rate per \$1,000 of assessed value required to produce these amounts is estimated to be \$1.24 in 2027, \$1.16 in 2028, \$1.10 in 2029 and \$1.02 in 2030. The exact levy rates and amounts to be collected are subject to legal limits at the time of levy. Exemptions from taxes may be available to certain homeowners, contact Snohomish County Assessor 425.388.3433 or Skagit County Assessor 360.416.1780.

## Argument For

We heard you— *No New Taxes!* This is a no tax increase *replacement* levy. It replaces the existing levy which expires at the end of this year and would result in no additional tax, maintaining the current levy rate. Without this funding our district *cannot* fund the following: Athletics, *Para Educator Staff, and Community Center Rent.*

School levies provide essential funding for District operations, academic programs, extracurricular activities, music, all athletics, Community Center rent/heat, para-educators, substitute teachers, groundskeepers, maintenance staff, and bus drivers. These levy dollars are needed to close the gap between what the District receives from the state and federal governments and what it needs to fund essential District operations. This vote is for a *set dollar amount.* If your property values go up, the school does *not* receive more money.

Our school is the center of our community. It not only educates our children, provides healthy meals, and offers athletics programs leading to higher academic achievement, but also allows space for DJAA activities for children. The District is the second largest employer in Darrington, providing much needed jobs for local residents. Without this critical funding our school is at risk, and our community will be severely impacted.

*Healthy Schools = Healthy Community!* We have to ask ourselves, What kind of community are we? What kind of community do we want to be? In the past, our community has voted, with pride, to support its school. Let's come together and vote *Yes* for kids and for our community.

## Rebuttal of Argument Against

The district heard the community's concerns and is running this levy as a replacement only. A *Yes* vote will result in no additional cost to taxpayers and will maintain important programs like 6th -12th grade sports and small group classroom support. The district has made significant spending cuts to keep the budget in balance. Reducing funding and staff even more will be damaging to students. Vote *Yes* for our kids and our community!

## Argument Against

We are deeply grieved to recommend voting *No* on this proposed school levy. It pains us to say it, but the Darrington School District's spending path is unsustainable and must change now. Our community cannot continue down this road.

Sixteen school employees earn over \$100,000 for only nine months of work, excluding benefits (fiscal.wa.gov). Twenty-two percent of the budget already goes toward employee benefits alone, while insurance, utilities, and maintenance costs keep climbing. Darrington is Snohomish County's most impoverished town, with a median household income of about \$66,000. Families and retirees here are struggling daily, making hard sacrifices—the district must finally show the same fiscal discipline.

Academic performance remains deeply concerning despite high spending. Fewer than 60% of students are proficient in math and English (reportcard.ospi.k12.wa.us). Only 33% of third graders read at grade level. Children who cannot read proficiently by third grade are four times more likely to drop out. These poor results demand urgent improvement.

The previous levy's failure sent a clear message from the community: real change is needed. Falling enrollment reflects ongoing unresolved parent-district conflicts. The district receives \$24,273 per student annually. Are we getting the results we pay for? We are standing on a fiscal cliff. A "No" vote will force the district to prioritize essentials and control spending. Rather than more taxes simply supporting the administration, please volunteer to support our children academically through tutoring or classroom help. Our children deserve better outcomes, not just bigger budgets. Please vote wisely. Vote *No.*

## Rebuttal of Argument For

We still don't feel heard. Where is the concrete plan to raise academic achievement, repair parent trust, and build a sustainable budget? This district appears to prioritize high salaries over results: twenty-three employees earn between \$90,000 and \$180,000 excluding benefits, yet we graduate students who can barely read. A levy failure means a ten percent cut. Before demanding more taxpayer money, the board must put children's education first, not adult jobs. Vote *no* until priorities change.

## Hospital District 304 Proposition No. 1 Levy Lid Lift for Health Care Services

The Commission of Skagit County Public Hospital District No. 304, Skagit County, Washington (United General District 304) adopted Resolution No. 2026-04 concerning the district's regular property tax levy. If approved, this proposition would provide additional operating and capital funds for United General District 304 to provide additional healthcare services to its residents and other persons served by United General District 304. It authorizes a maximum regular property levy rate for collection in 2027 of 50 cents per \$1,000 of assessed value. The 2027 levy amount will be used for the purpose of computing the limitations for levies in subsequent years.

### Argument For

Skagit County Public Hospital District No. 304 (United General District 304) provides impactful disease prevention and health promotion programs to our community.

This proposition would strengthen these efforts by supporting our seniors, enhancing access to nutrition, increasing family services, empowering youth to make positive choices and promoting overall community health. These programs are designed to address both immediate needs and long-term well-being, creating a healthier and more resilient population.

Most of these programs and services currently depend on grant funding from outside our area. Those funds are shrinking and unpredictable. They also come with limits and may not address all of our community needs. This levy would stabilize funding and shift control back to our community. We can decide what services matter most and keep them available.

### Explanatory Statement

Written by Hospital District 304

Skagit County Public Hospital District No. 304 operates United General District 304 ("District 304") and provides disease prevention and health promotion services to the residents of the public hospital district. In addition, District 304 ensures hospital and other health care services are available locally.

Under state law, public hospital districts are authorized to levy regular property taxes at a rate of up to 75 cents per \$1,000 of assessed value for purposes of operating and maintaining hospital and other healthcare facilities and services and promoting health, wellness and prevention. State law limits the amount that taxes can increase without voter approval. District 304's current levy rate is approximately 9 cents.

District 304's board has determined that it is necessary and in the best interest of the residents served by District 304 to request approval of a levy at the rate of 50 cents per \$1000 assessed value, which would be an increase of 41 cents from its current rate starting in 2027. The levy will provide additional operating funds for essential programs that promote health and wellbeing at every stage of life by supporting seniors, enhancing nutrition access, increasing child and family services, empowering youth, and improving community mental health.

## Fire Protection District No. 8 Proposition No. 1 Property Tax Levy for Fire Protection and Emergency Services

The Board of Skagit County Fire Protection District No. 8 adopted Resolution No.5-2026 concerning a proposition to maintain and adequately fund District Operations. This proposition would finance fire protection and emergency medical services by restoring the District's regular property tax levy in 2026 to an amount not to exceed \$1.25 per \$1,000.00 of assessed valuation and authorize setting the limit factor at 103% for each of the following five years. The maximum allowable levy in the final year shall serve as the base for subsequent levy limitations as provided by Chapter 84.55 RCW.

### Argument For

When someone calls 911, *every minute matters*. Skagit County Fire District 8 serves more than 10,000 residents in Lyman, Hamilton, Sedro-Woolley (outside city limits) and surrounding rural communities. Firefighters respond to about 1,100 emergencies each year — and those calls have increased nearly 58% since 2019. Volunteer availability has declined sharply as economic pressures force many to work longer hours, limiting their ability to respond during daytime emergencies.

The district's fire levy rate has gradually fallen from the \$1.25 per \$1,000 voters approved in 2019 to about \$0.89 today. Proposition 1 would restore the levy to the level voters previously approved. Importantly, this is not a general fund tax like many city taxes. Every dollar from this dedicated levy goes directly to emergency response and the operation of your fire district.

This funding would allow the district to hire two additional full-time firefighters to improve response coverage and reduce reliance on outside agencies. It would also help replace aging fire engines and water tenders. The district operates with a balanced budget, carries no debt, and passes independent audits.

Reliable emergency services protect lives, homes, and our entire community. This measure helps ensure Fire District 8 has staffing, equipment, and resources needed to respond quickly when you or our neighbors need help. Please vote Yes on Proposition 1.

### Explanatory Statement

Written by Fire Protection District No. 8

Skagit County Fire Protection District No. 8 provides emergency fire protection and emergency medical services to its citizens. Due to the statutory 1% limitation on property tax increases, the Fire District's current levy has dropped to approximately \$.89 per thousand in 2025. The maximum regular levy rate for Washington fire districts is \$1.50 per \$1,000 of assessed value.

If approved by the voters, this proposition will authorize the District to restore its levy rate to \$1.25 per \$1,000 of assessed valuation in 2026 for collection in 2027 which is the same rate previously approved by the voters in 2019. The proposition will also allow the District to keep pace with inflation by establishing an annual growth factor of 3% per year. The dollar amount levied in the 2031 and collected in 2032 shall serve as the District's future tax levy base.

The Board of Commissioners has determined that this proposition is necessary to provide for public and fire-fighter safety and to maintain an effective level of service. This includes firefighter staffing, and replacing emergency apparatus and equipment in light of rising costs, higher call volumes and the continued growth of our community.

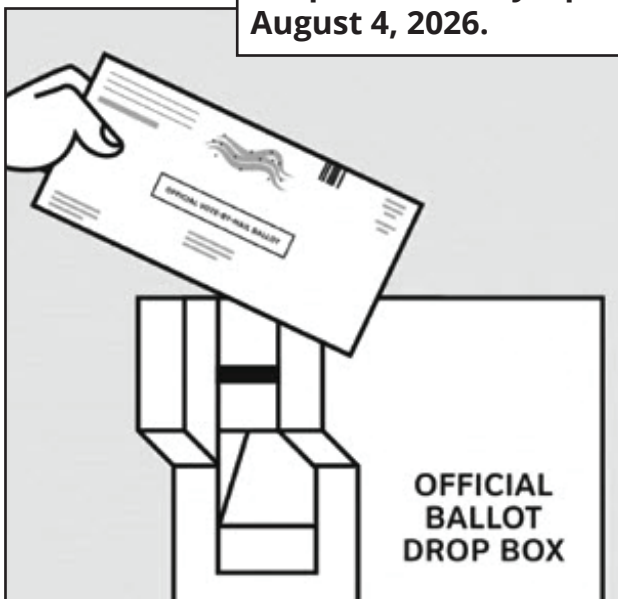
